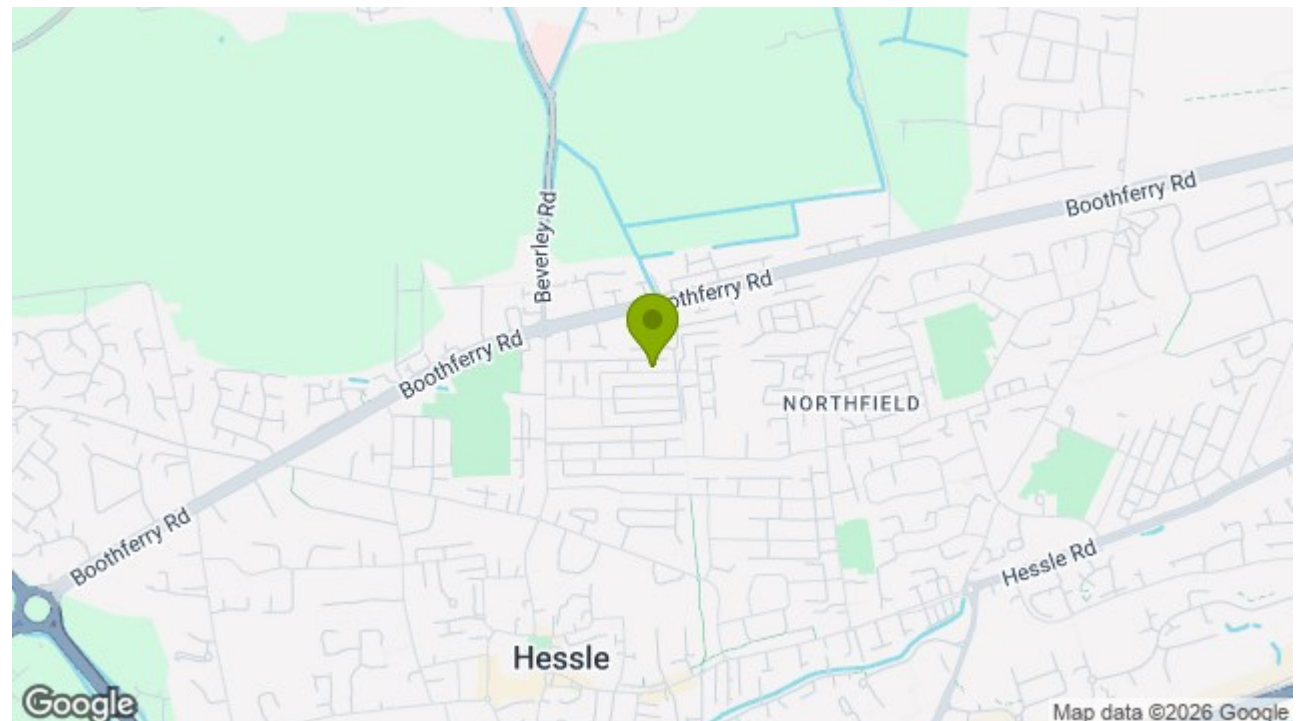

HESSLE

ENTRANCE HALL
