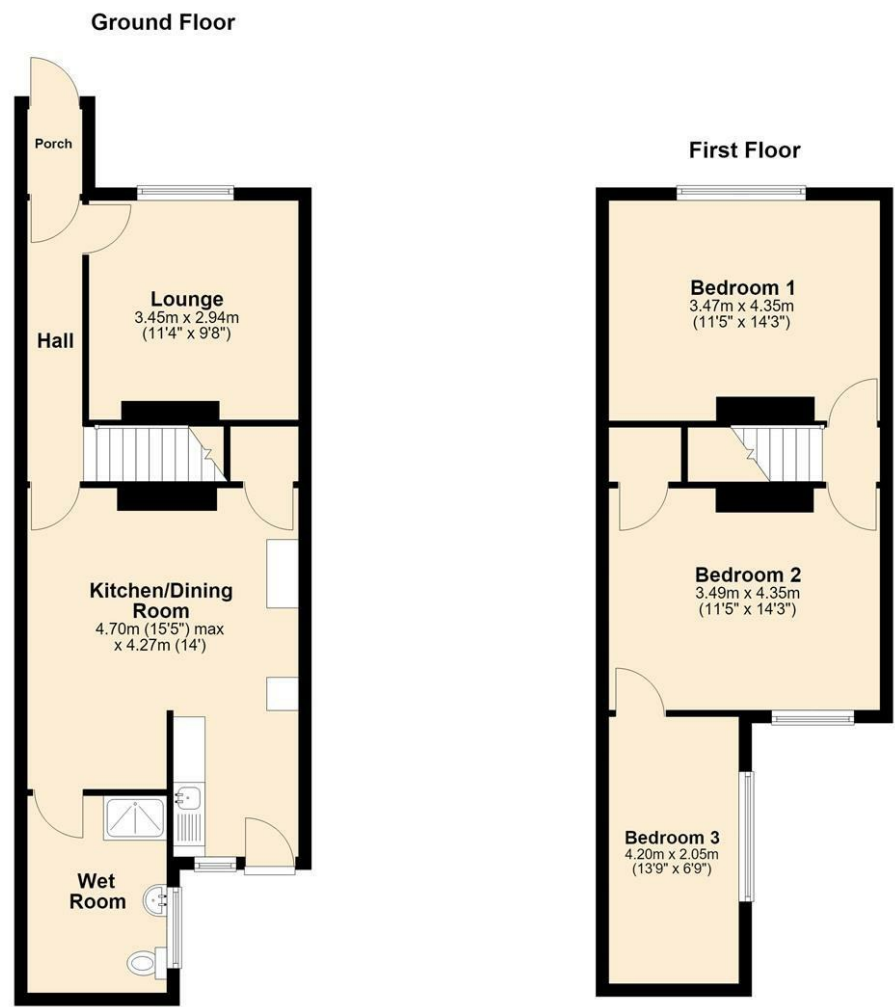

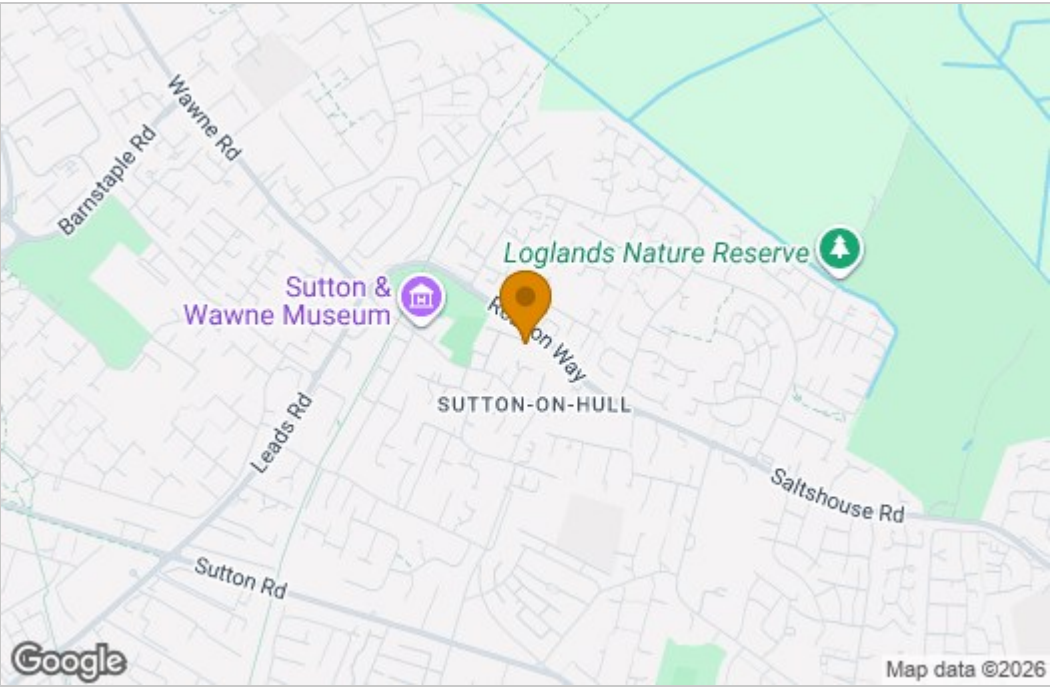

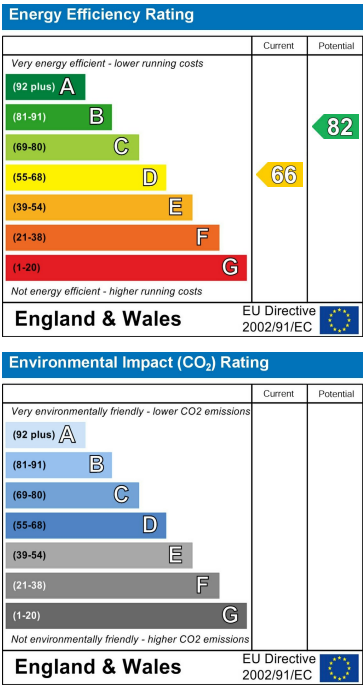
Floor Plan
