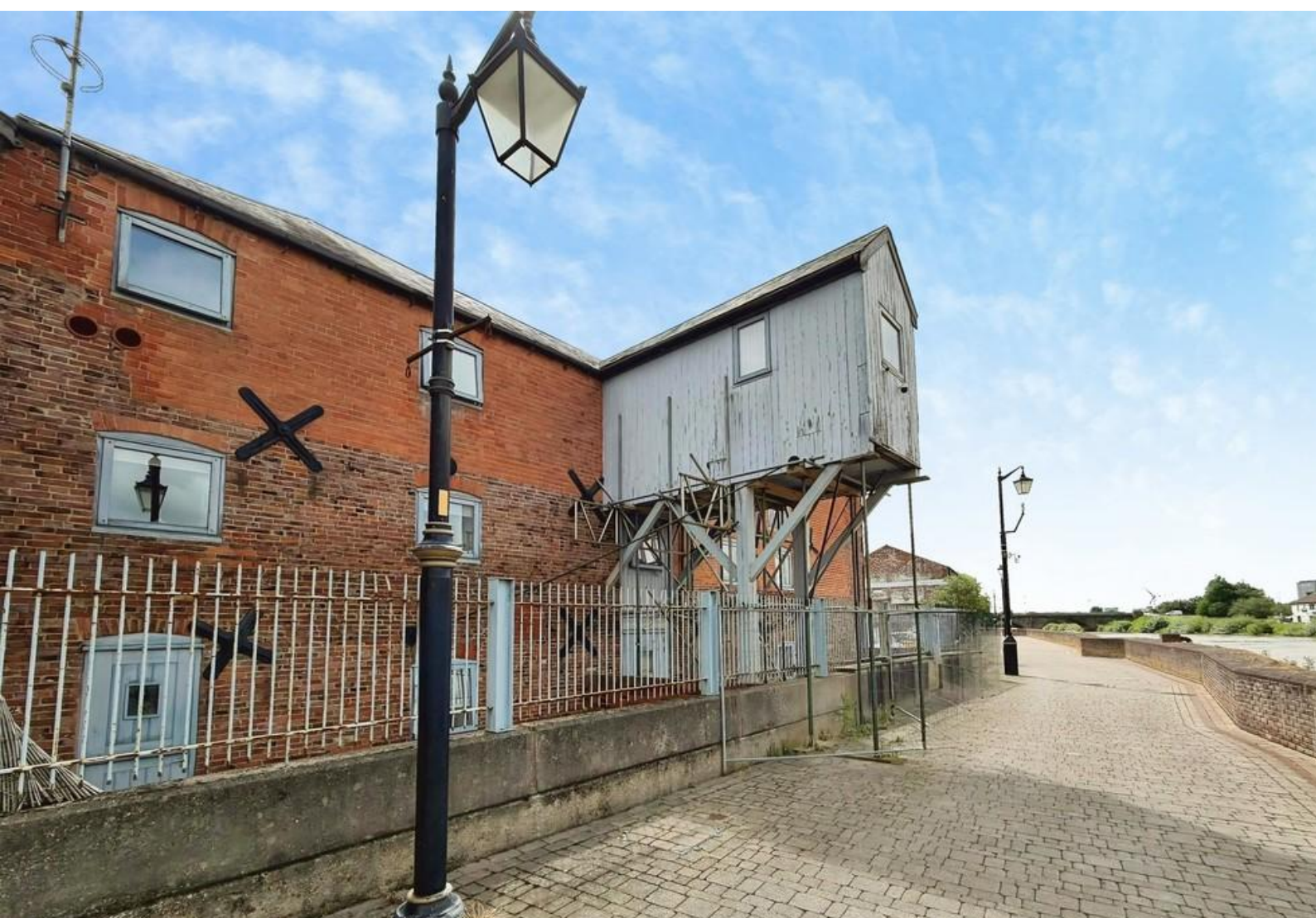
Externally, the property benefits from allocated parking and offers an excellent opportunity for first-time buyers, professionals, downsizers or investors alike.
