To the first floor you are met with three bedrooms and a modern bathroom suite, to the second floor a converted loft/fourth bedroom with a separate wc. Outside the property has its own driveway with parking for multiple cars, outbuilding with fitted shower room and a generous rear garden.



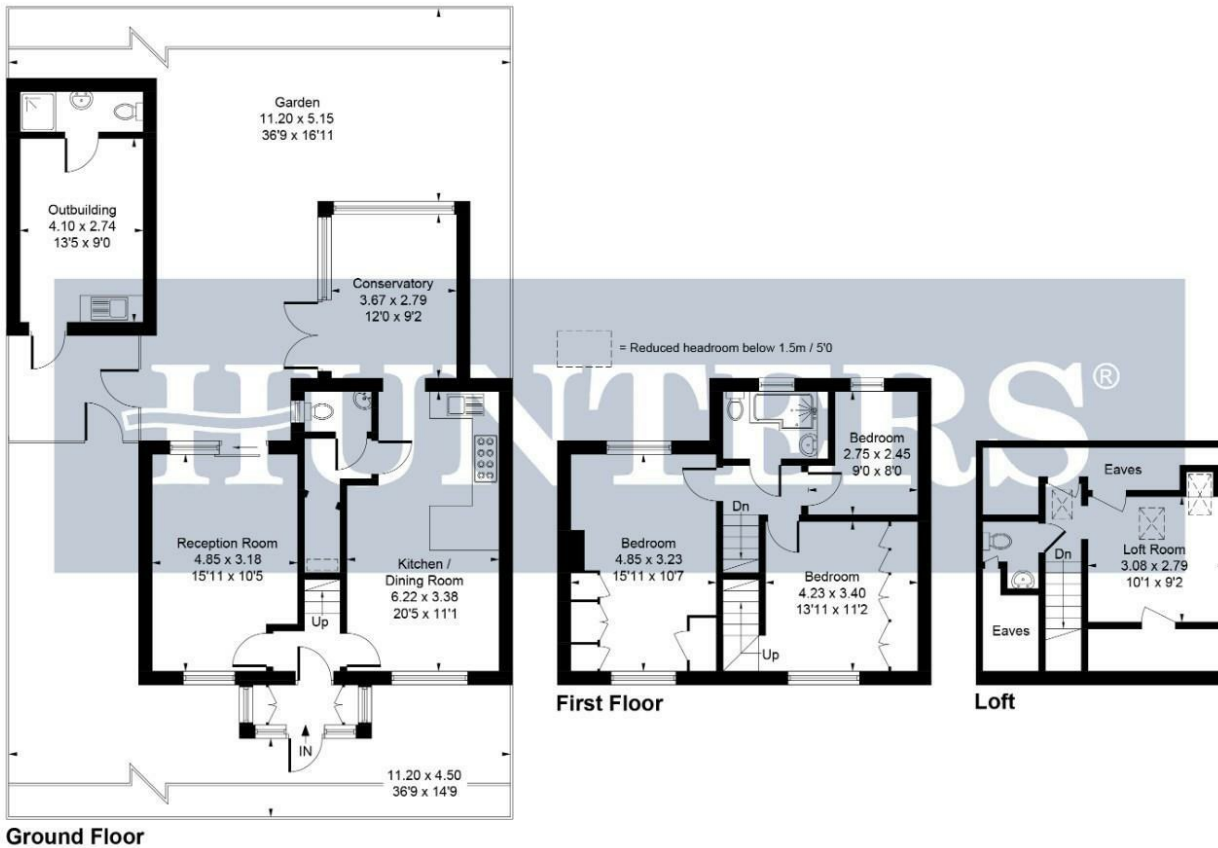
