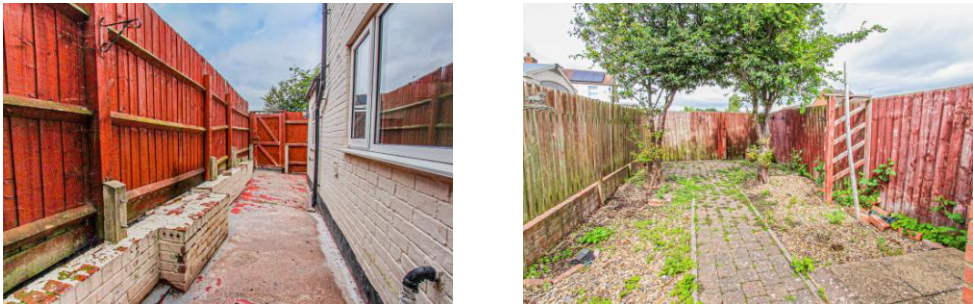

Offered with no upward chain is this well presented mature three bedroomed mid terraced property situated in a popular location off Station Road with benefits to include gas radiator central heating, uPVC double glazing, built in kitchen appliances and offers a 23ft lounge/dining room, 15ft kitchen/breakfast room and a low maintenance landscaped garden. The accommodation briefly comprises entrance hall, lounge/dining room, kitchen/breakfast room, utility room, three bedrooms, bathroom, front and rear gardens.
