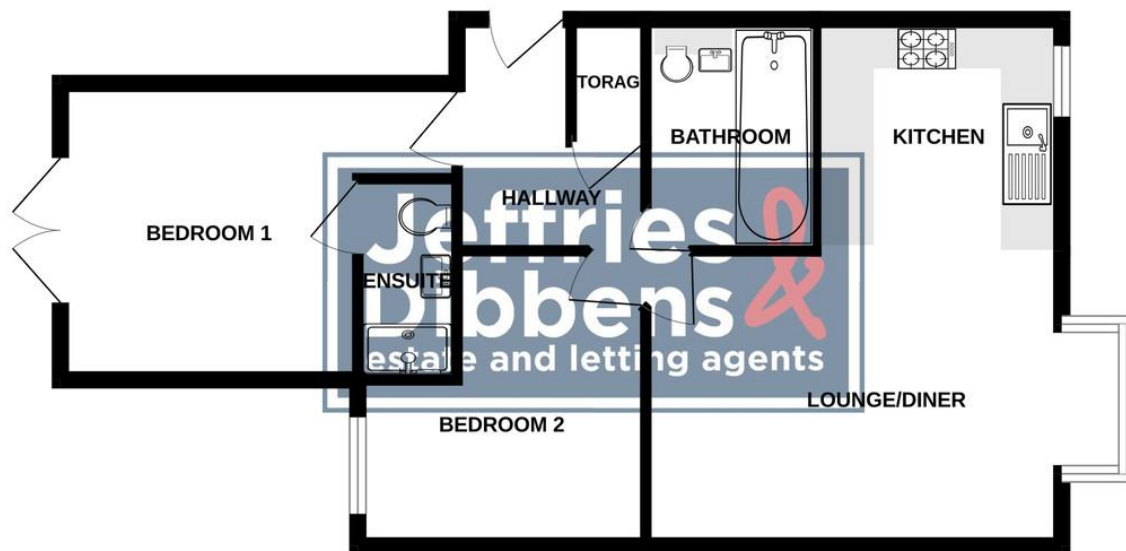

GROUND FLOOR



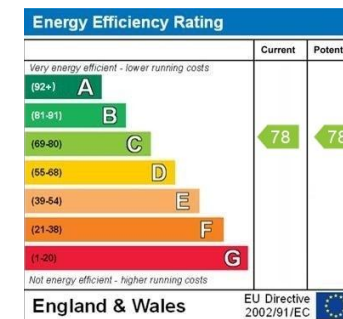
