Outside there are communal grounds including an allocated parking space for the apartment.

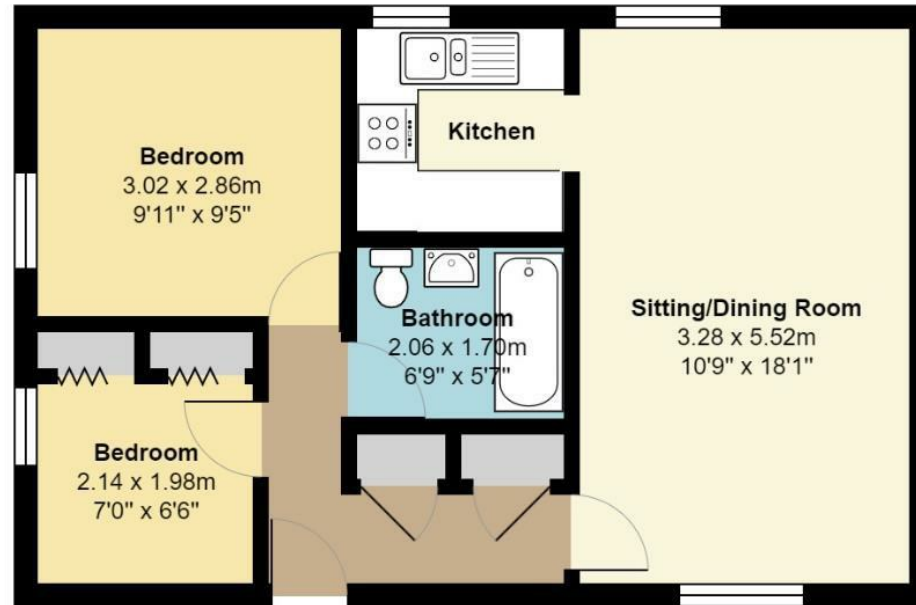
**COUNCIL TAX:** Council Tax is levied by the Local Authority and is understood to lie in Band B.

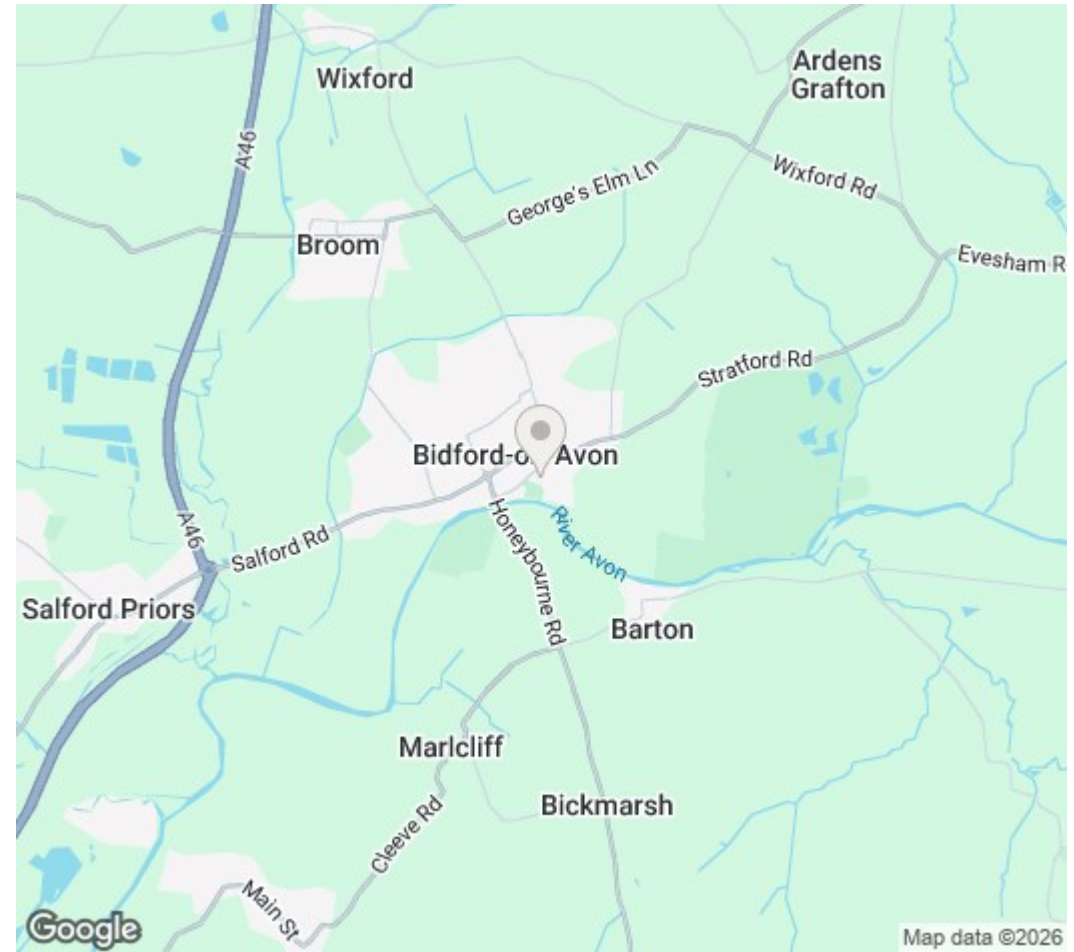
