Pembroke Cottage is a beautifully presented three-bedroom, four-bathroom home with landscaped gardens and gated parking for two cars. Set in an elevated position, the property enjoys far-reaching views over the Thames Valley and offers well-balanced accommodation arranged over three floors.

The cottage is approached via a gated entrance, with parking for two vehicles just a few steps from the front door. On entering, you are welcomed into a large stone hallway. To the left is the wonderful vaulted-ceiling reception room, featuring a striking glass wall that frames far-reaching views across the Thames Valley. Adjacent to this space is a generous study, which opens on to a private balcony overlooking the gardens.

Two bedrooms are also on this level. One has a large en-suite bathroom, while the other has a spacious dressing room.





A bespoke stone staircase, set beneath a Soane-style glass skylight, forms the architectural centrepiece of the home. This feature allows light to filter down through the spine of the cottage. At the top of the stairs, the principal suite occupies the entire first floor, comprising a large bedroom with views over the rose gardens and an exceptionally spacious bathroom.

The lower ground floor houses a bespoke kitchen with granite worktops, an oak-beamed ceiling, and a gas-fired AGA. The kitchen also accommodates a dining area for eight and features a brick fireplace with a gas-fired log stove. Two sets of patio doors open on to the garden and outdoor seating area.

From the kitchen, a further reception room provides additional living space, also with direct garden access through a third set of patio doors. A compact study is tucked just off this room. The utility room is accessed from the kitchen and includes a side door to the garden. Two further bathrooms are located at the base of the staircase, completing the layout.






Location


