Located on a popular residential road, within walking distance of Langley grammar school, B Simmons are delighted to present to the market this spacious mid-terrace home offering more than meets the eye. The property has been extended and comes with the benefit of rear vehicular access leading to a 16'6 x 13'0 garage. An internal viewing is highly recommended. As you enter through the front door you walk into an inviting entrance hallway with stairs leading to the first floor and a door provides access to a spacious living room. An archway takes you through from the hallway where the current owners spend most of their time; a beautifully extended 'L' shaped kitchen and dining room with French doors leading out to the rear garden. On the first floor there are three well proportioned bedrooms, all having built in wardrobes, and a separate contemporary family bathroom, fitted with a matching white suite and a mains shower over the bath. Outside there is a private rear garden which has been landscaped by the current owners, partly laid to lawn with a dedicated barbeque area, with a large raised decked area for outside entertaining. To the front of this well presented home there is a low maintenance garden laid to stones with a walled front and a pathway to the front door. The property also benefits from having a large garage with power and lighting, to the rear of the property accessible via a service road from Randall Close.

The property is ideally located approximately 500 yards from Langley grammar school, whilst other local grammar schools are within walking distance. There are also many primary and secondary schools within a short walking distance. Langley railway and Elizabeth line station is just 0.9 miles away, whilst there is easy vehicular access to M4, M25, M40 and Heathrow. Shops, services and amenities can be found on Trelawney Avenue.

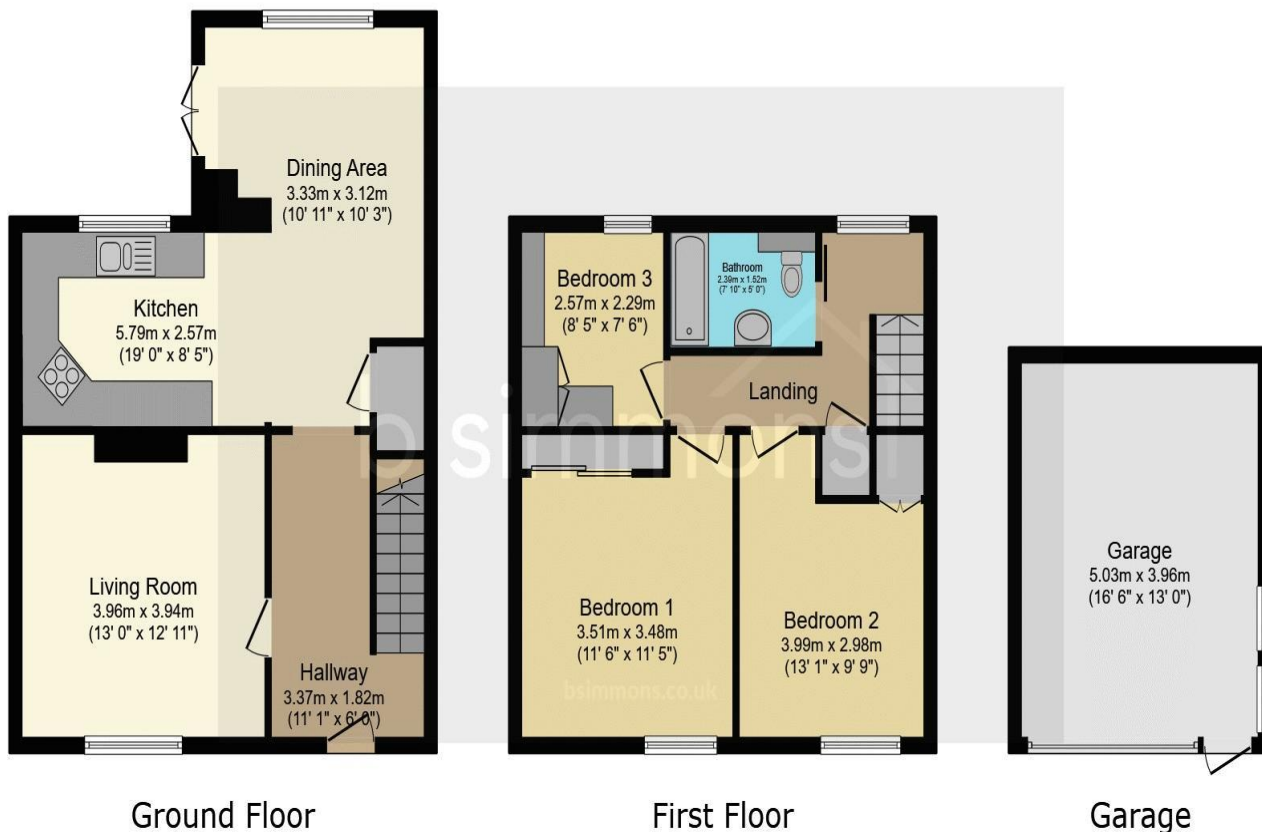
