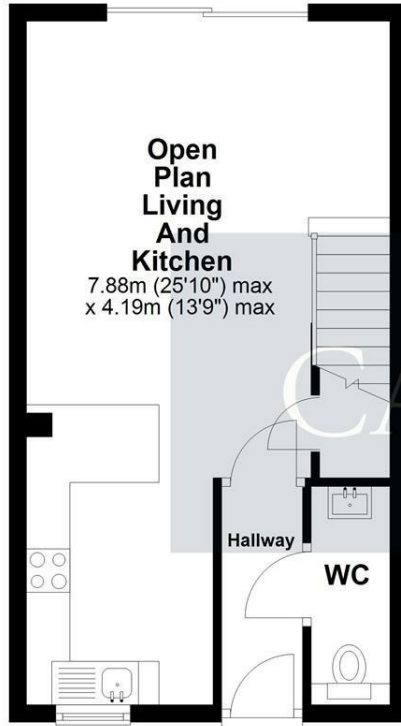

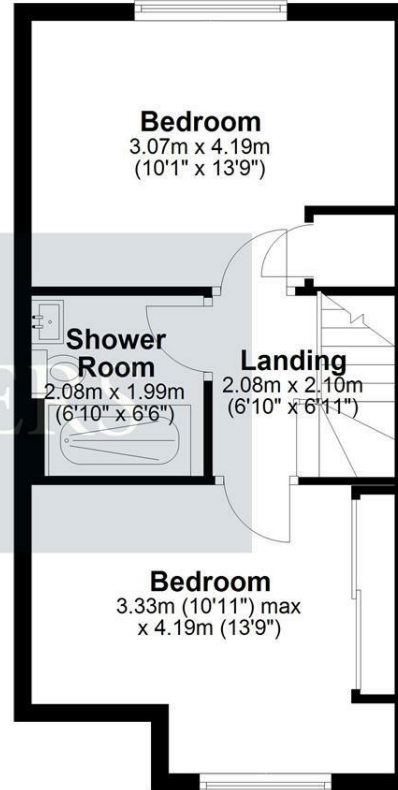
Ground Floor
