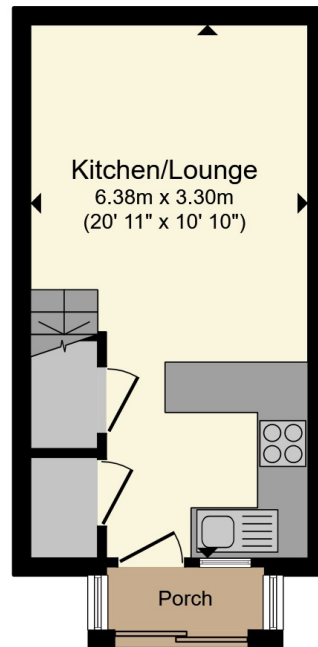




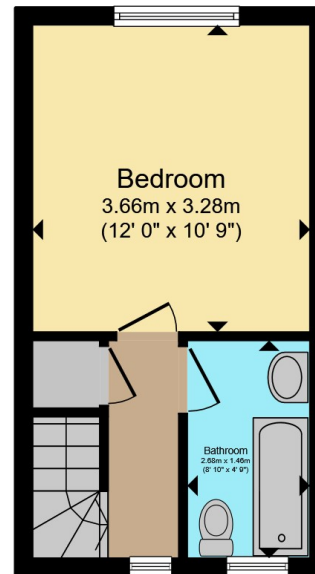








**Ground Floor**
