Follow Grandstand road until you reach the T junction. At the junction opposite the supermarket, turn right into Sandown Drive, continue on this road and take the next left into Doncaster Avenue. Continue along Doncaster Avenue follow the road around to the right and Nicholson Court will be found immediately in front of you.

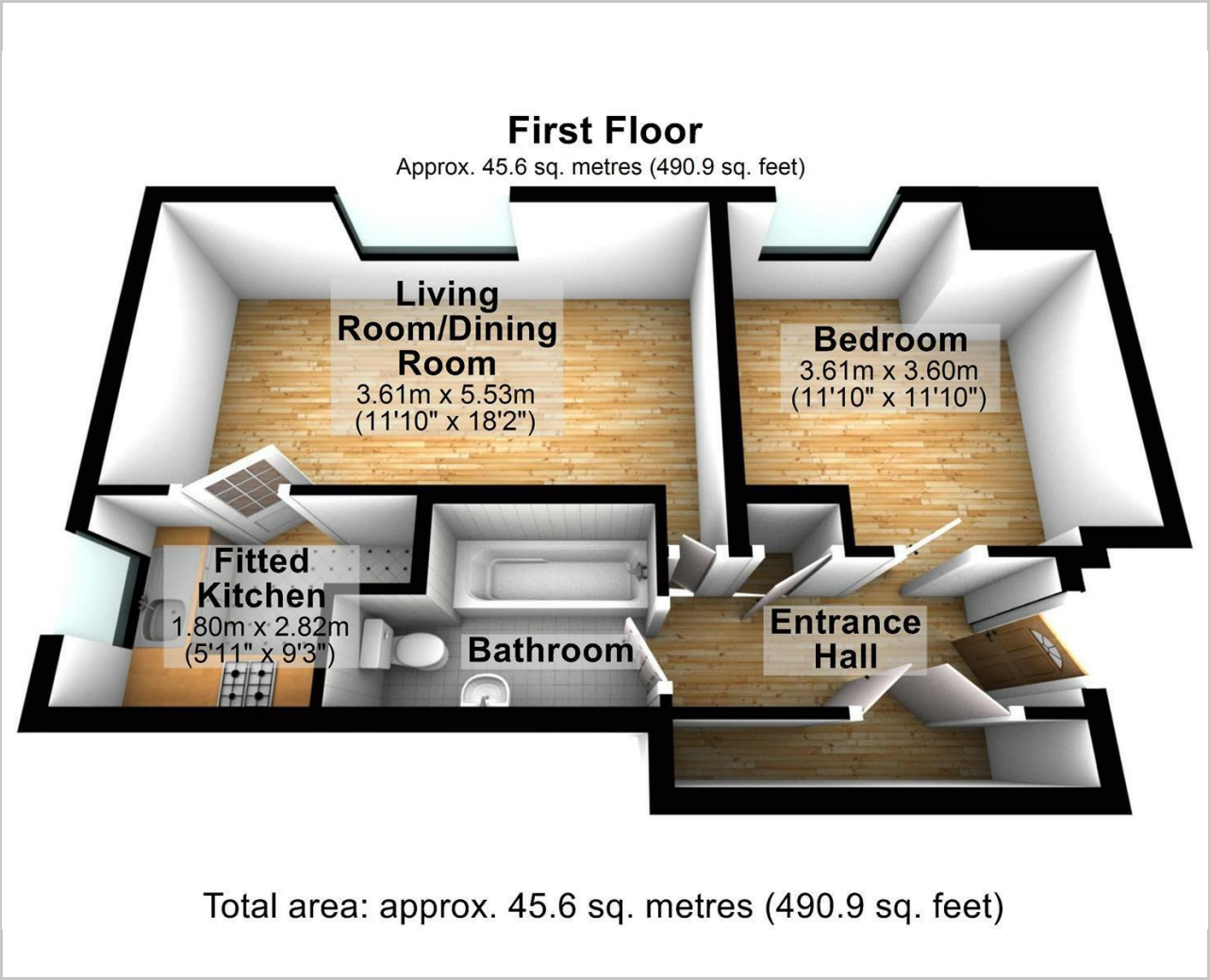

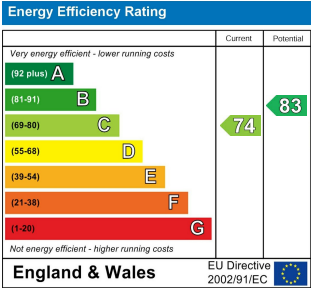
Floor Plan
