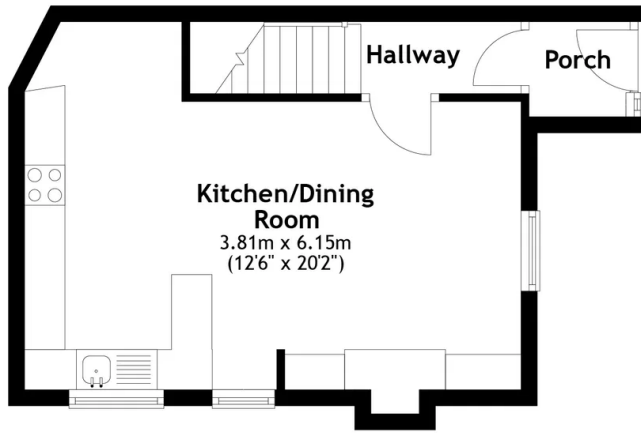

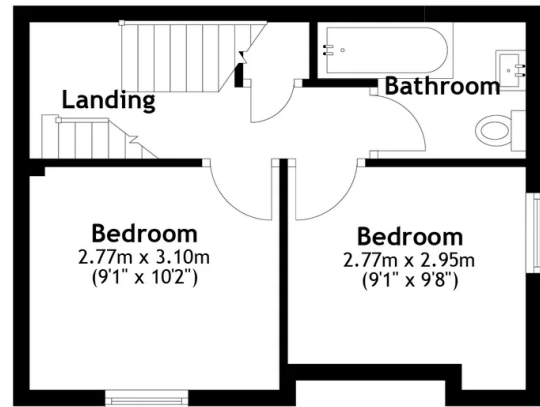

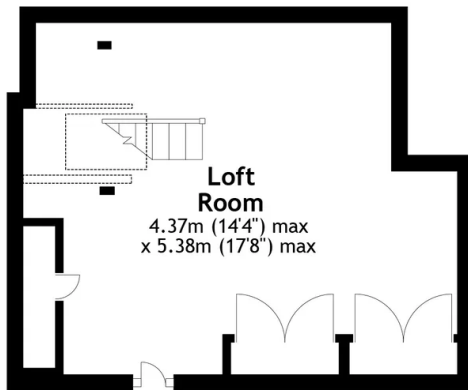
First Floor
