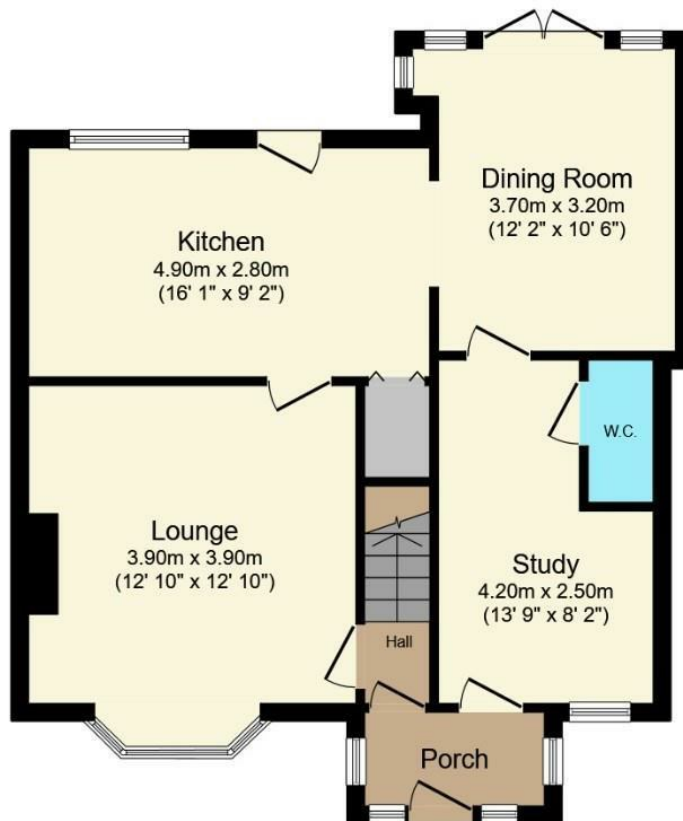

One unique feature of this property is the study at the front, complete with a convenient WC. This versatile space could be used for a variety of purposes, from a home office to a relaxation retreat.

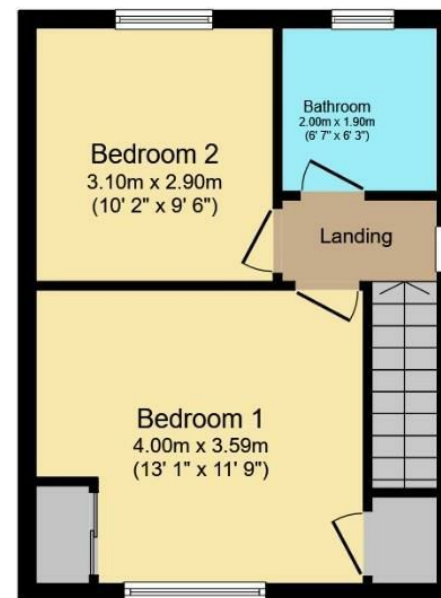

Ground Floor

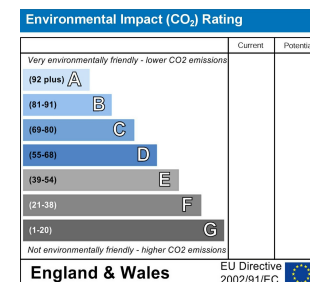
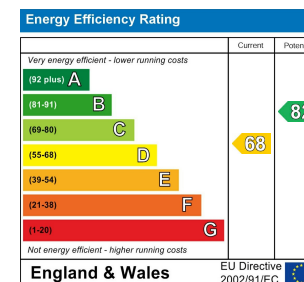


First Floor

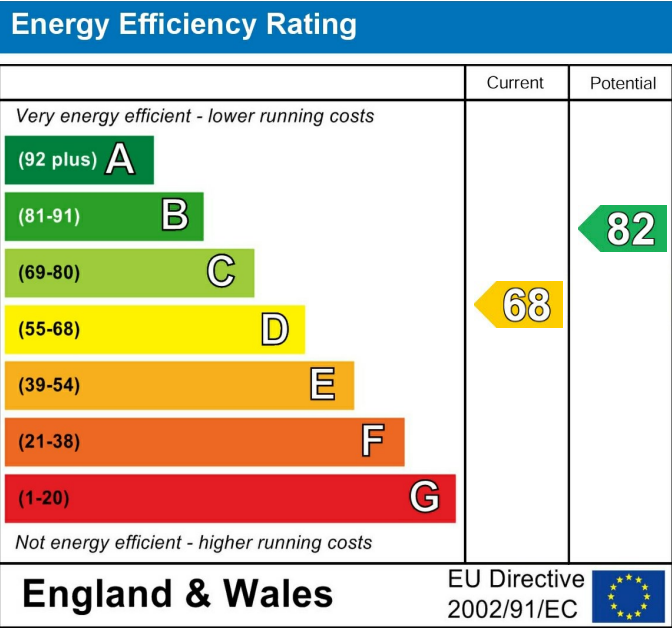
