



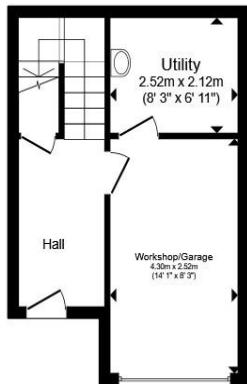

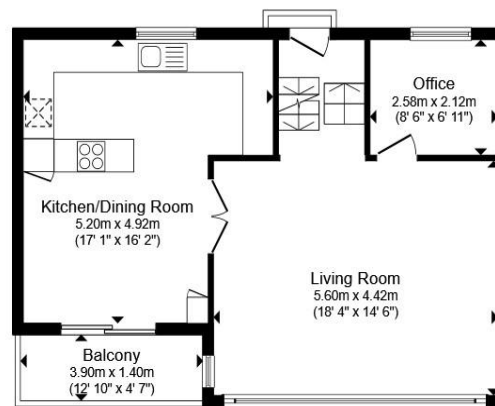

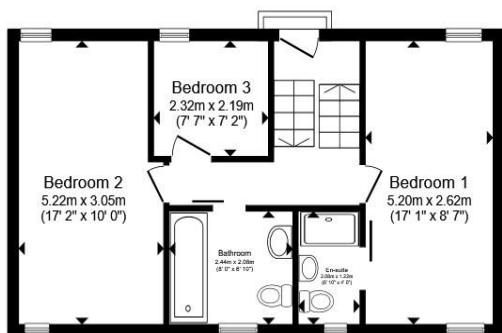




**Ground Floor**
