House - Terraced



A three bedroomed end of terrace period cottage with off street parking and lovely rear gardens.

The property benefits from double glazing, oil fired central heating, new boiler (2024) and new roof covering and insulation. The accommodation includes a spacious kitchen/dining room with wall and base units and an under stairs pantry area. The spacious living room has exposed ceiling beams, wood floor and a log burning stove. The conservatory over looks and opens to the rear garden. To the first floor there is a master bedroom with built in wardrobes and two further good sized bedrooms. The shower room has been refurbished and is fitted with a new suite including shower cubical, wc, sink and new tiling and floor covering. Externally there is a double driveway providing off street parking for several vehicles and to the rear a good sized garden with patio, lawn and large garden store/workshop. The village is close to the A167 and within easy reach of Northallerton Town Centre and Railway Station (approx 4 miles) and is on the Coast to Coast walk.

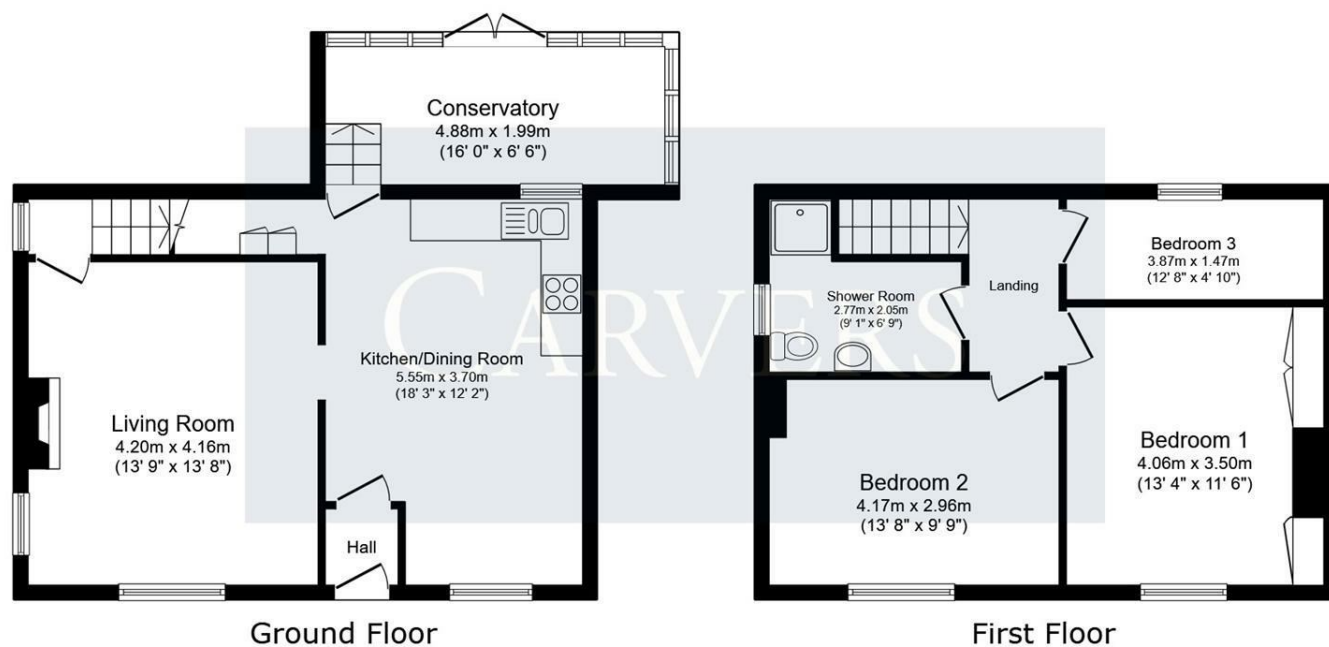
