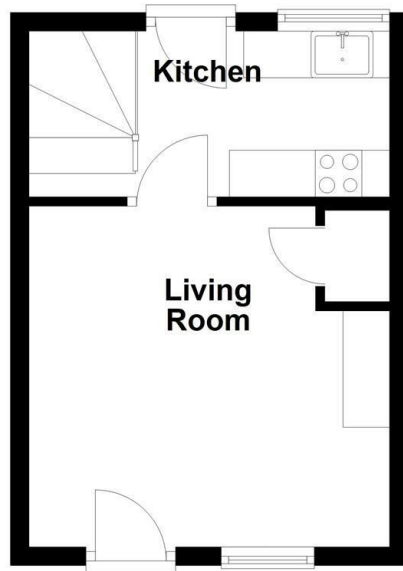

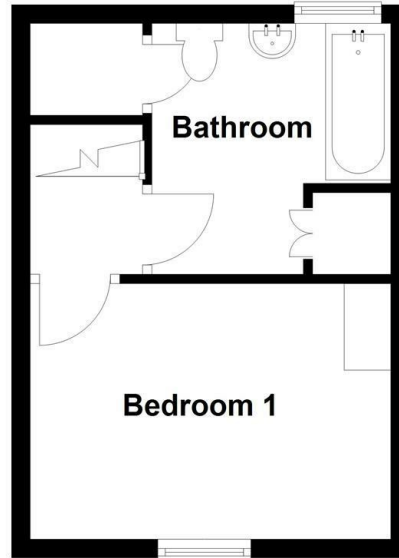

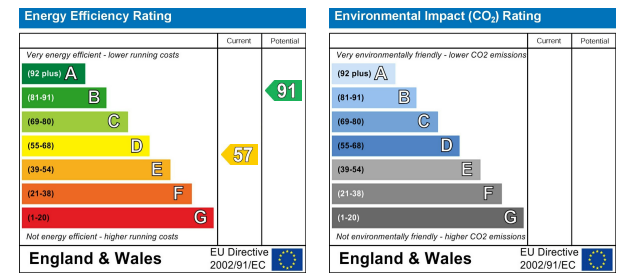
Ground Floor

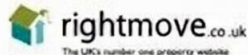
