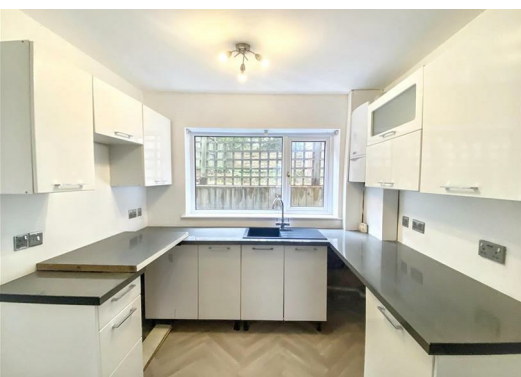
A 2-bedroom end-terrace home in popular Kingshill, offered with no chain and ideal as a first home or investment.
