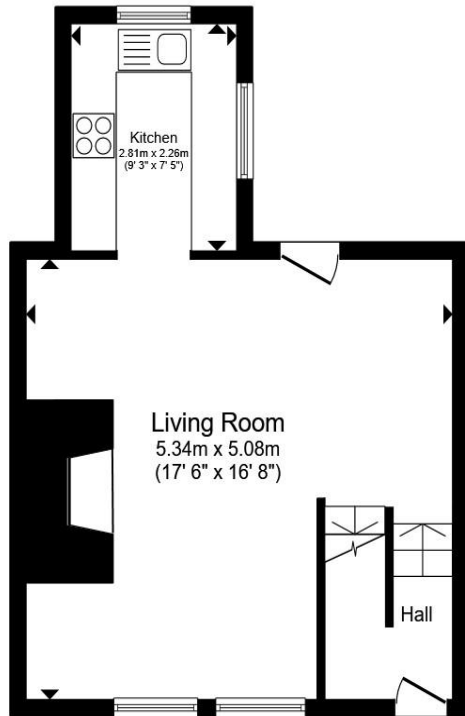

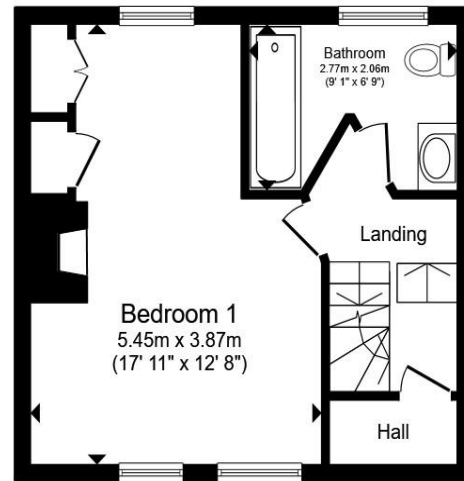

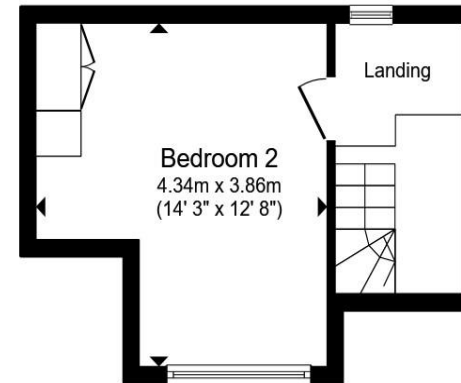




Ground Floor
