## Entrance

Via Opaque Upvc double glazed door with matching side screen and glazed door to lounge/sitting room.

## Lounge/Sitting Room

14'5" x 9'1" max widening to 12'11" (4.4m x 2.78m max widening to 3.95m)

With Upvc double glazed window to front having electric heater under. Artex ceiling with coving. Archway to open plan kitchen area and laminated wood block style flooring leading into inner hall way and in turn to double bedroom and bathroom. Also storage cupboard.

## Kitchen

9'9" x 5'11" (2.98m x 1.82m)

Offering a range of eye and base level cupboard units, drawer space and work tops having tiled surrounds, built in

oven and four ring electric hob. Inset single drainer stainless steel sink unit. Plumbing for automatic washing machine and under work top power point. Sealed unit double glazed window side. Artex ceiling and laminated wood block style flooring.

## Double Bedroom

12'11" x 8'2" min (3.94m x 2.5m min) Plus door recess and airing cupboard housing hot water cylinder. Glazed / timber door and sealed Upvc double glazed window to rear. Electric heater.

## Bathroom

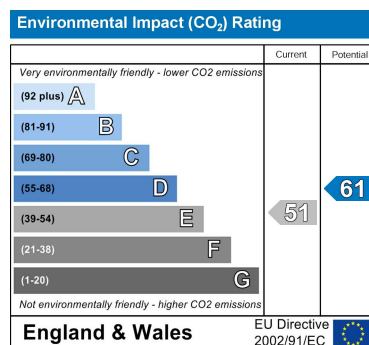
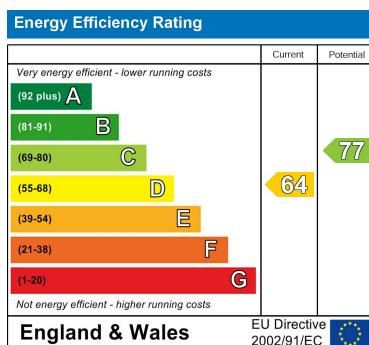
