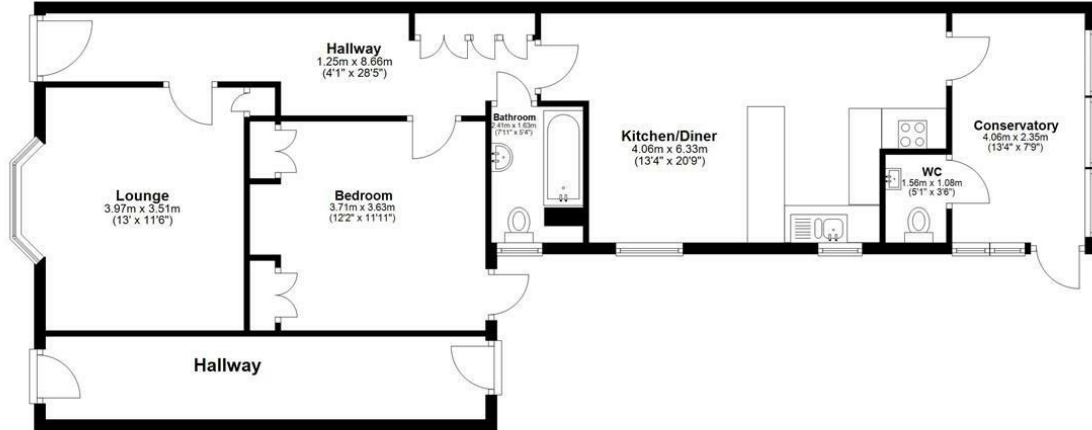

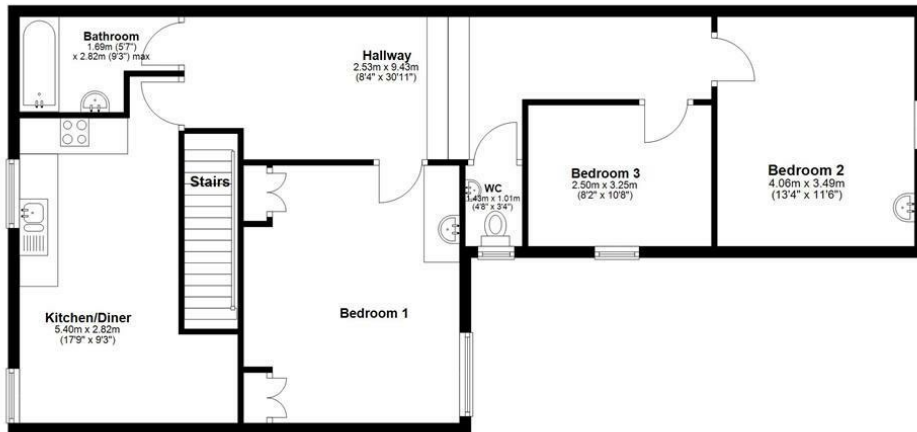
Ground Floor
