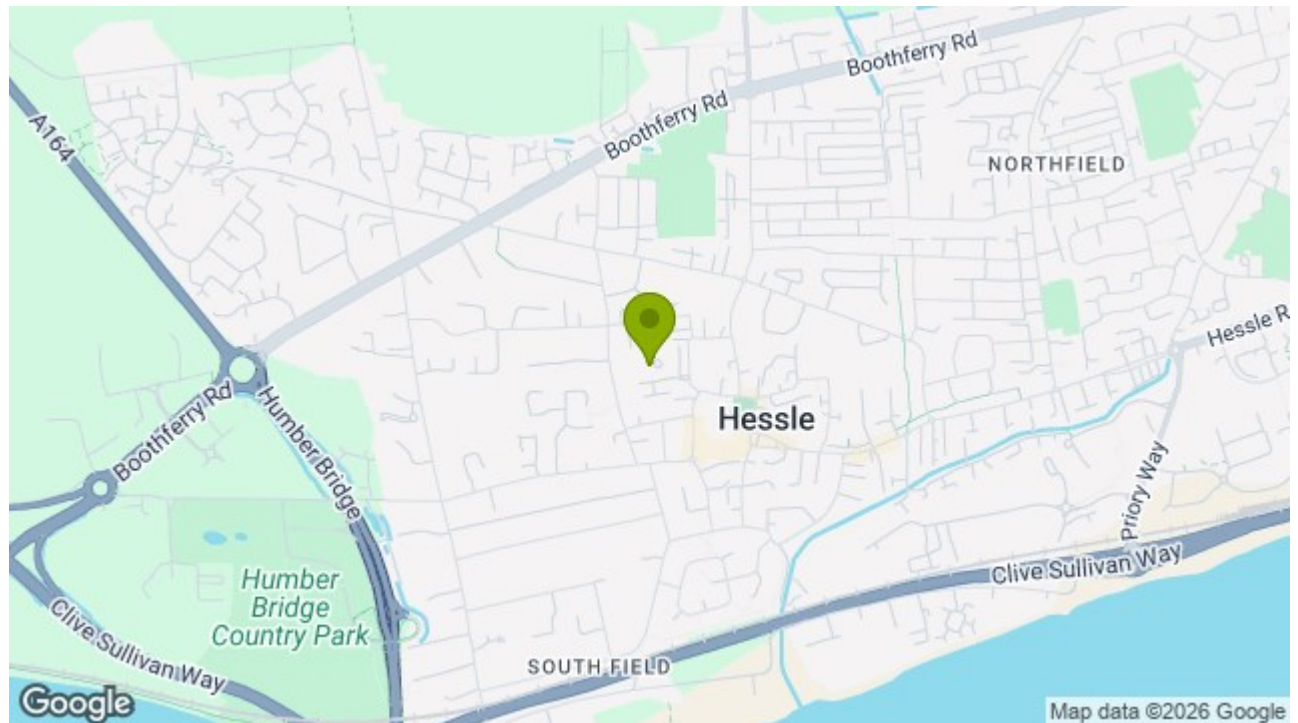

HESSLE

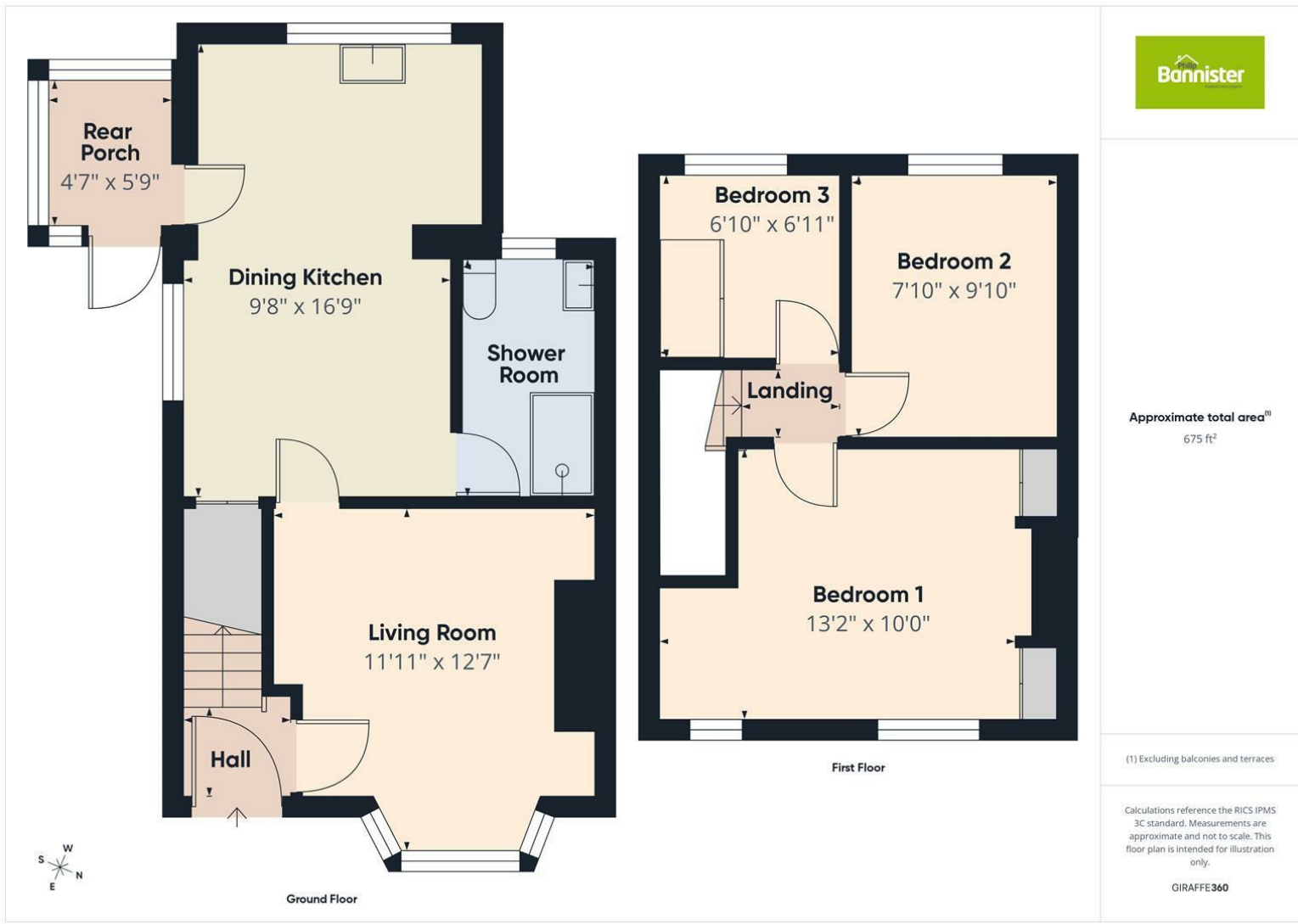
