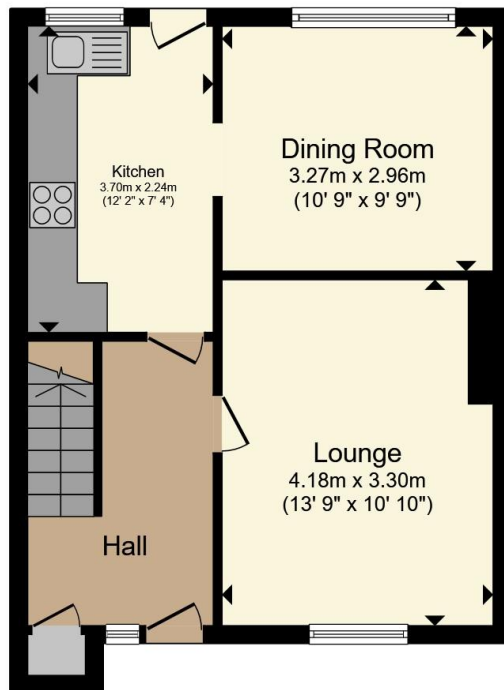

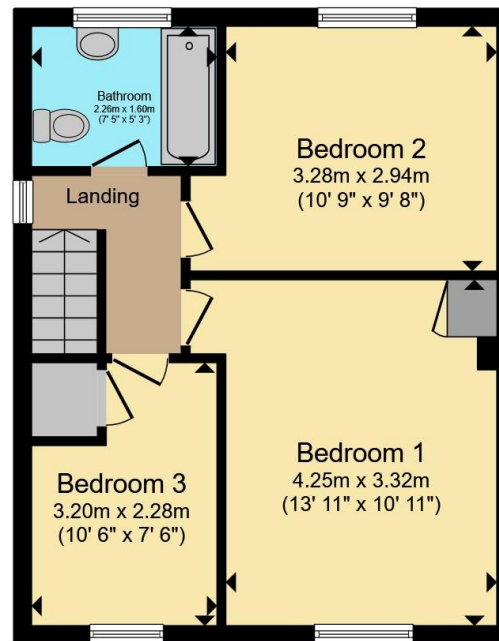








**Ground Floor**
