





FORMING PART OF A STUNNING GRADE II LISTED PROPERTY – a very attractive two-bedroom ground floor apartment with allocated parking space.

This beautiful Grade II listed property has been lovingly converted by local developer Ware to provide fourteen one, two and three-bedroom apartments and one, two-bedroom coach house, the majority of which retain the original stone mullion windows and two of which retain original fireplaces.

Wilkie May & Tuckwood are delighted to be able to offer this newly converted two-bedroom apartment. The accommodation comprises in brief: access up impressive flight of stairs on the right hand side of the house through front door into communal hallway with door into the apartment.

From the hallway doors open to the lounge/diner, bedrooms and bathroom. The lounge/diner is a lovely double aspect room which retains one set of mullioned windows and has steps leading down to the kitchen. The kitchen is fitted with a modern range of wall and base units, sink and drainer incorporated into work surface and fitted appliances to include electric oven and hob with extractor hood over, dishwasher and fridge/freezer. There is also space and plumbing for a washer/dryer and a window to the side.

There are also two bedrooms and a bathroom fitted with a modern three piece suite.



Positioned as it is in the building, this property also enjoys lovely views over the communal gardens towards North Hill.

A management company will be set up to deal with the maintenance of the gardens and parking area, the maintenance and cleaning of the common areas of the building and the insurance of the whole building. There will be an initial service charge payable of approximately £100 per month.

Outside, the communal gardens are to the side and rear and predominantly laid to lawn with seating areas.

The property also has one allocated parking space.
