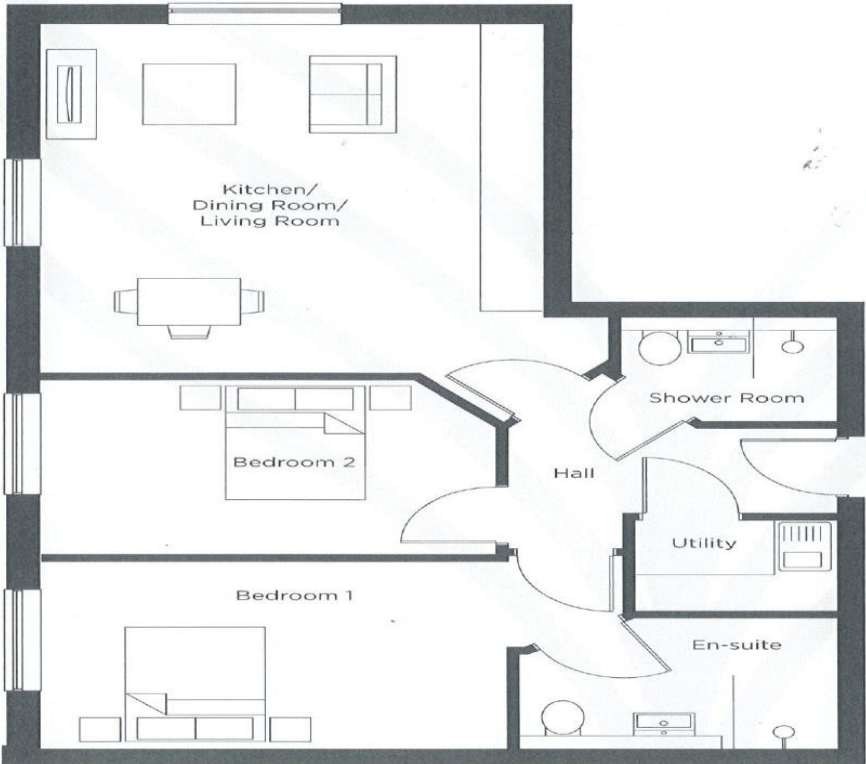




Floor Plan
