The sale offers an excellent opportunity to purchase part of an owned croft with de-crofted building plot, located in the desirable coastal village of Arisaig, only a short walk from the sea. Enjoying stunning views over the surrounding countryside to Ben Roshven, the croft, and site, extends to around 1.2 acres and benefits from Full Planning Permission for a detached property, with building warrant in place.

Location

Arisaig is a popular village, situated on the road between Fort William and Mallaig - "The Road to the Isles". With its coastal situation, it is an ideal location from which to explore this extremely attractive part of the Highlands & Inner Isles. The village itself has a marina, hotel, restaurants, shop, post office, two churches, primary school etc with further facilities available at Mallaig, including a secondary school, and Fort William - to which there is a link by both road and rail.

Planning Permission

Full Planning Permission was granted on 22nd March 2024 (Ref:23/02793/FUL) for the erection of an attractive detached dwellinghouse. There is also a building warrant in place. Copies of this Planning Permission and approved plans are available on the Highland Councils website or on request with the selling agent.

Croftland

The croft for sale is outlined red on the title plan and extends in total to approximately 1.2 acres. The areas shaded green are the decrofted house and garden sites (Area 2 has active planning, as outlined above, and Area 1 previously held planning - Ref No: 11/00769/PIP). Services
