Partly laid to lawn and with a large private patio area which is ideal for entertaining. There is also gated side access and French doors into the garage.

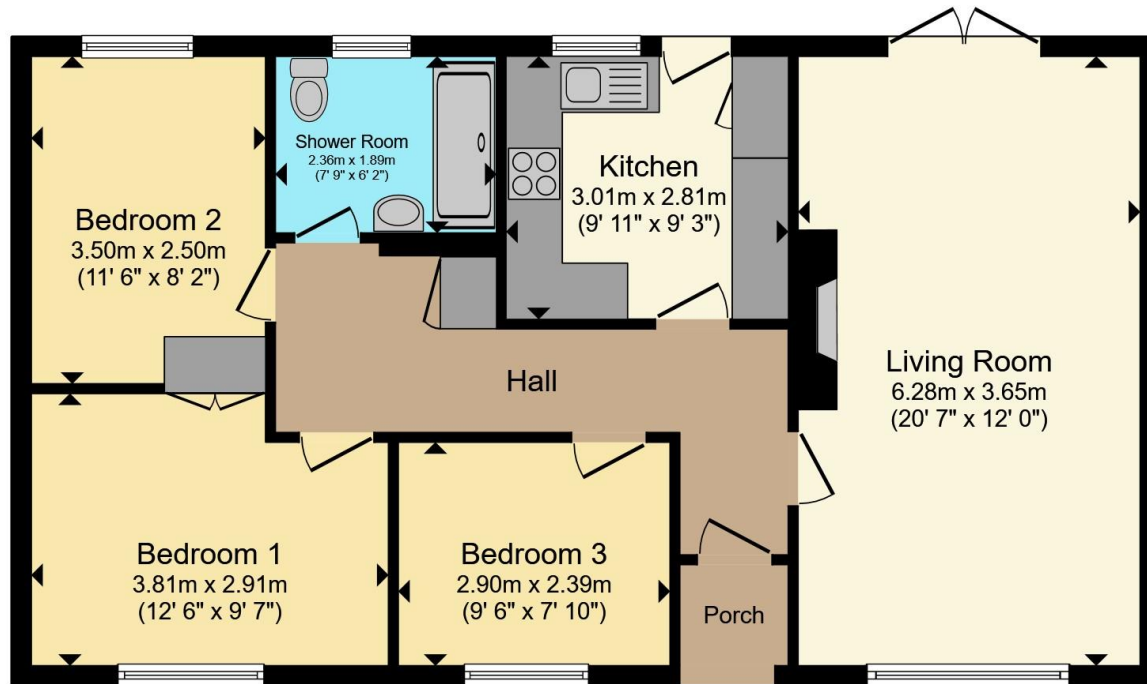
Double Garage
