Location

The lands are situated in the town-land of Brackna, approximately 8km south of Athy and 7km north of Stradbally. Access is via a quiet cul-de-sac road (L80601) connecting to the local road network, providing convenient access to the surrounding towns and wider regional routes. South Kildare is widely recognised for its productive agricultural soils and strong demand for well-sized land holdings, and this property represents a rare opportunity to acquire a substantial farm in one continuous block within this highly regarded farming area.

Description

The holding extends to approximately 52.6 hectares (130 acres) and forms part of Folio KE2685. The lands comprise a large, well-shaped block divided into workable fields with mature hedgerows and natural boundaries throughout. The breakdown of land use is approximately as follows:

- **Arable Land: c.40.46 hectares (100 acres)**
- **Grassland: c.8.49 hectares (21 acres)**
- **Woodland: c.3.64 hectares (9 acres)**

The tillage land is of excellent quality, while the grassland areas remain suitable for grazing or silage production. There is potential for the construction of a residence and yard on the land subject to obtaining the necessary planning permission.
