Catherine Court is designed for those aged 70 and over, who wish to maintain independence while benefiting from a well-supported community environment.

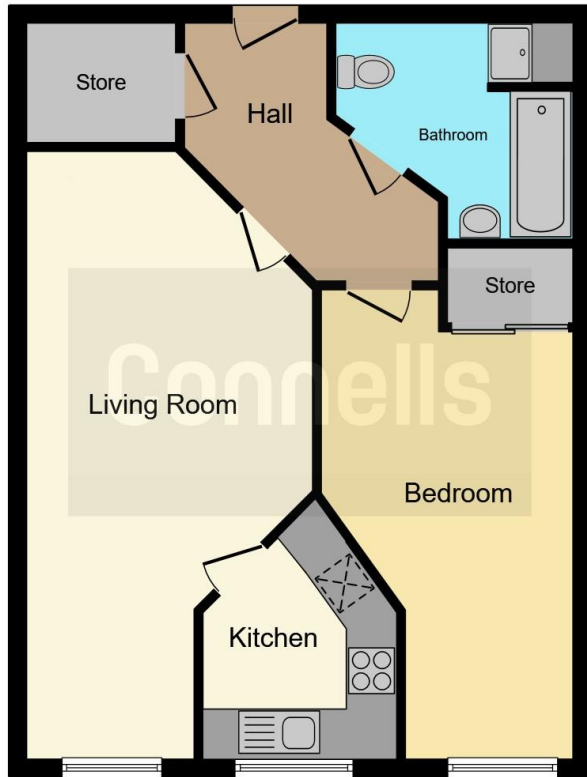
This means you'll be part of an active, friendly neighbourhood where you can feel at home and connected.
