Briefly the accommodation comprises; entrance vestibule, lounge, dining room and kitchen to the ground floor. Two bedrooms and bathroom to the first floor. To the front of the property is a small enclosed garden. To the rear of the property is a traditional sized enclosed cottage yard with further area to the rear for off road parking. This property is uPVC double glazed and warmed via gas central heating. Early internal viewing is strongly advised to fully appreciate the living accommodation contained within.

uPVC double glazed front entrance door opening into entrance vestibule. Door providing access to lounge.

LOUNGE

uPVC double glazed window to the front elevation with radiator beneath. Light and power points.

DINING ROOM

uPVC double glazed window to the rear elevation with radiator beneath. Light and power points. Door providing access to kitchen.

KITCHEN

Bright kitchen with uPVC double glazed windows to the rear elevation. Fitted with a comprehensive range of wall and base units with worksurface over with inset four ring hob with oven beneath. Plumbing for washing machine and space for fridge freezer. Tiled to walls and floor, spot lights to ceiling and power points.

LANDING

Access to bedrooms and bathroom.

BEDROOM ONE

uPVC double glazed window to the front elevation. Radiator, light and power points.

BEDROOM TWO

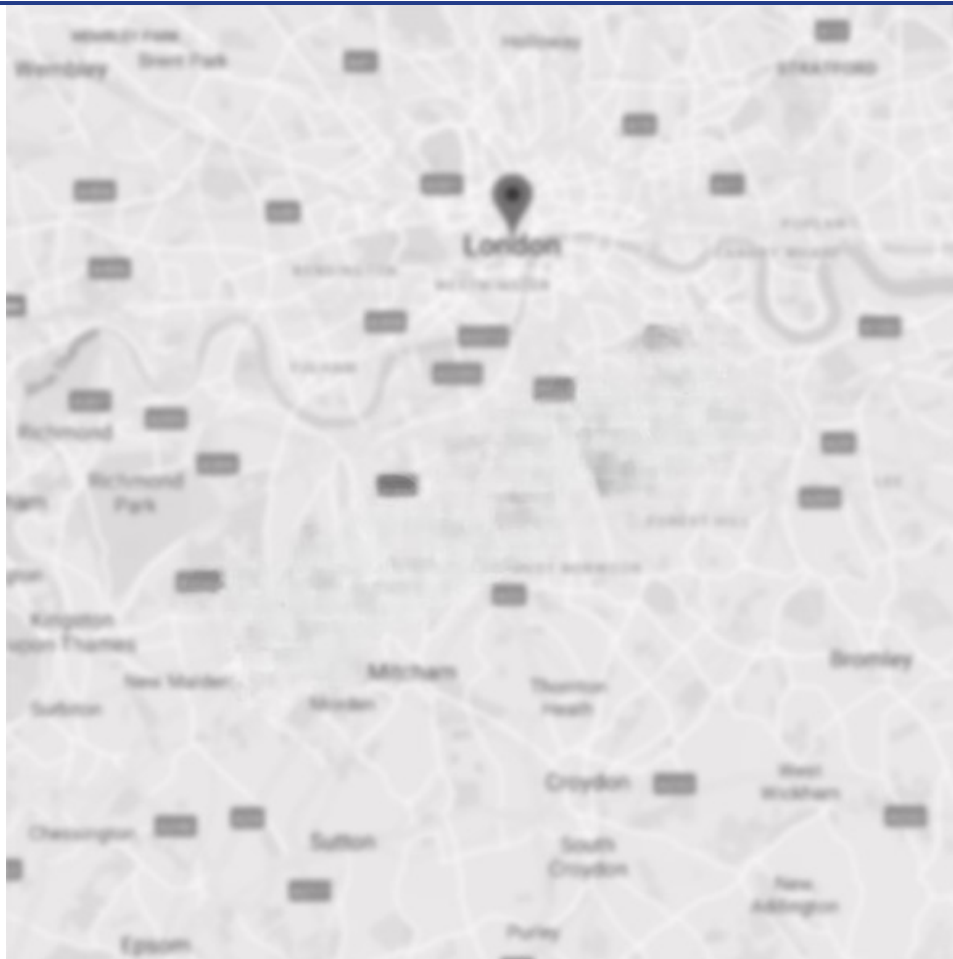
uPVC double glazed window to the rear elevation with radiator beneath. Light and power points.

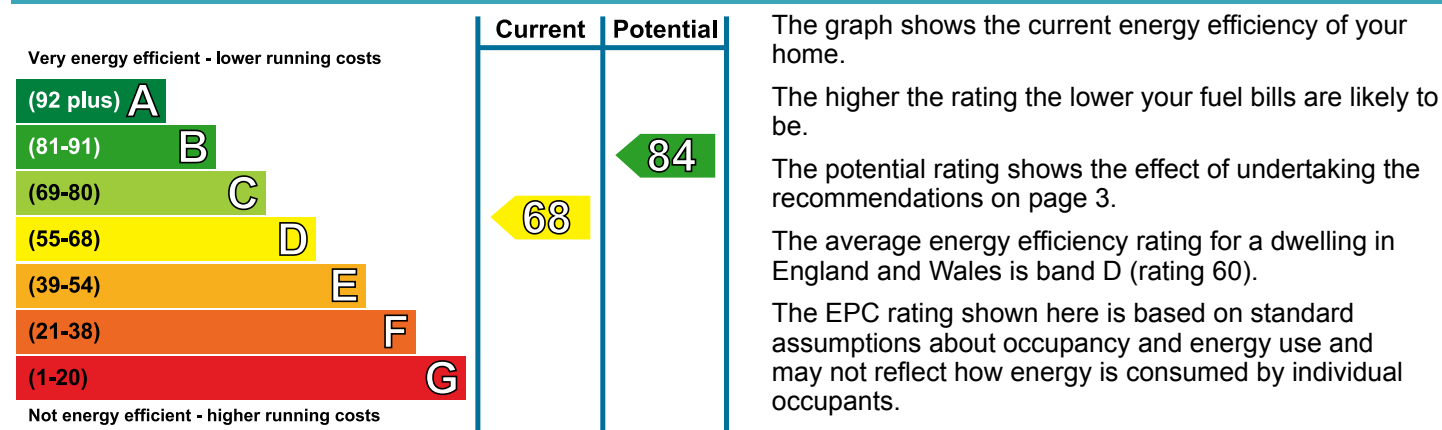

Financial Support and the Green Deal

About the impact of buildings on the environment

One of the biggest contributors to global warming is carbon dioxide. The energy we use for heating, lighting and power in homes produces over a quarter of the UK's carbon dioxide emissions.

The average household causes about 6 tonnes of carbon dioxide every year. Based on this assessment, your home currently produces approximately 2.8 tonnes of carbon dioxide every year.
