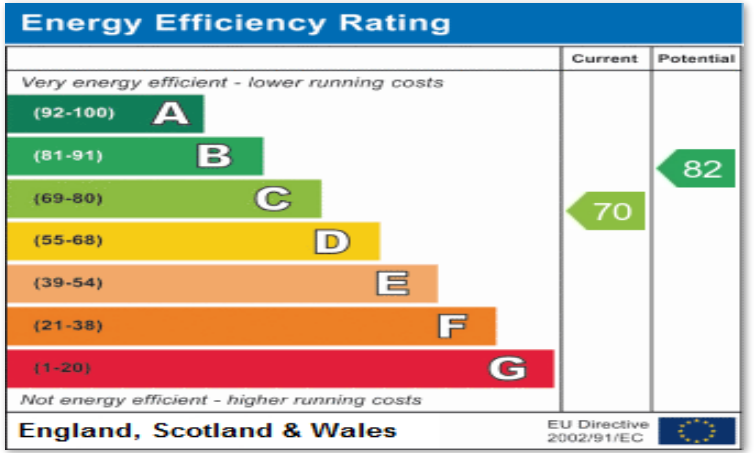




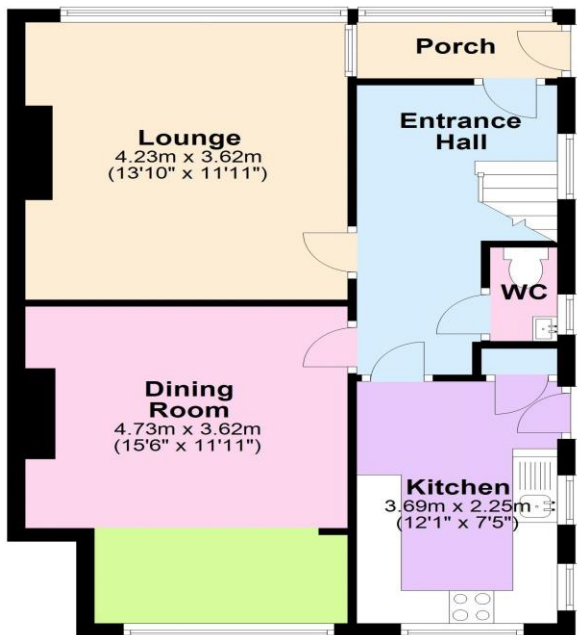

Providing spacious and well presented largely unfurnished gas centrally heated & UPVC double glazed accommodation, the property will suit a family or a professional couple, briefly comprising an entrance porch, entrance hall with separate w/c off, a lounge, dining room and fitted kitchen with appliances. Upstairs there are two double bedrooms and a single room or study and a house bathroom w/c. Externally there are low maintenance gardens and a drive for off street parking. Points to note: The garage is not included as part of the rental. Due to Article 4 planning restrictions, this property cannot be let to three or more unrelated people. A deposit equal to the first months rent will be required which will be registered with an approved scheme within 30 days of initial payment. A holding deposit of £100 is required when making an application. If the application is approved the holding deposit will go towards the first month's rent payment.





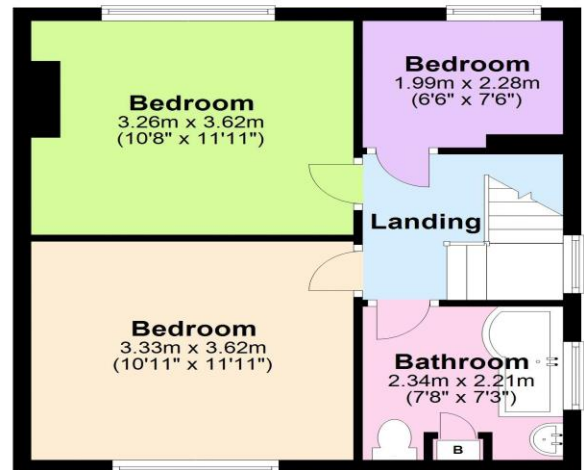
Ground Floor

Tenant application process

All prospective tenants will need to complete an initial application form. This can be emailed, collected from the office or downloaded from our website or click this [link](#). Applications will then be processed for credit checking and referencing. A holding deposit of £100 per property is due, which on confirmation of a successful application, will be deducted from the first month's rent. If an application is not accepted, Castlehill reserve the right to withhold some or all of the holding deposit if misleading or false information is provided on the application form or the tenant withdraws their application without good reason. In some cases a guarantor may be required. All rents are due at least one month in advance. A deposit of at least the equivalent to one month's rent will be required which will be registered with approved scheme. Smoking and pets are prohibited in all properties unless specifically agreed by Castlehill/The landlord. Fees may apply to tenancy variations, early termination of tenancies, late rent and any property lock/security device repairs/changes as a result of lost keys or tenant negligence.
