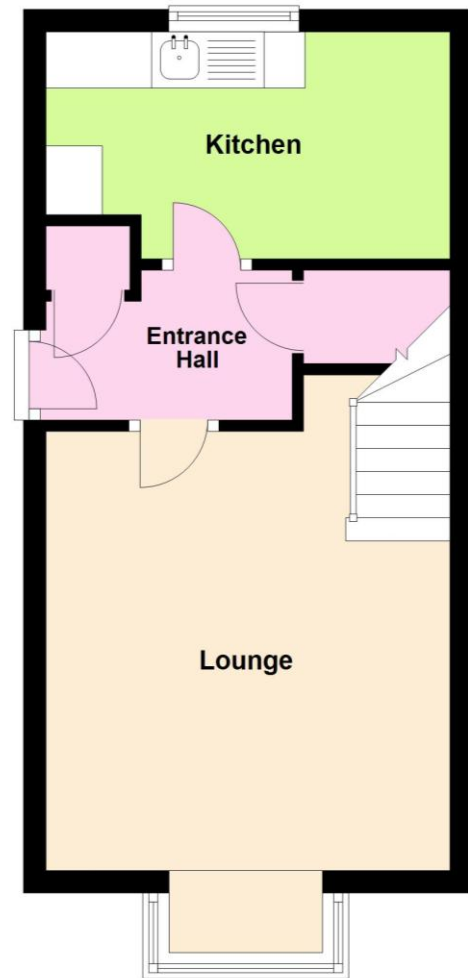




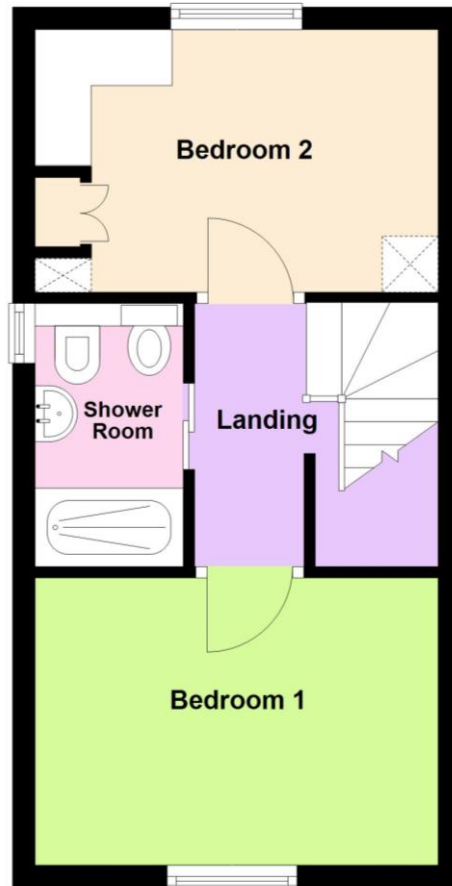
Ground Floor
