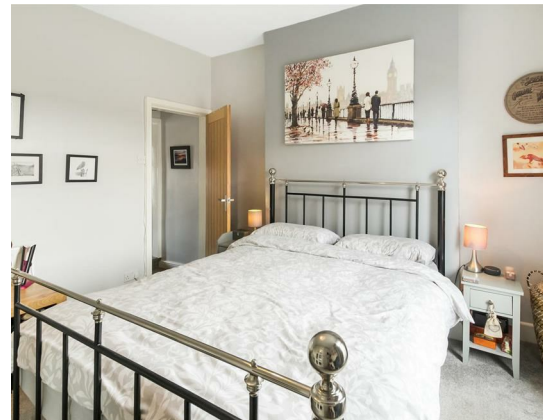

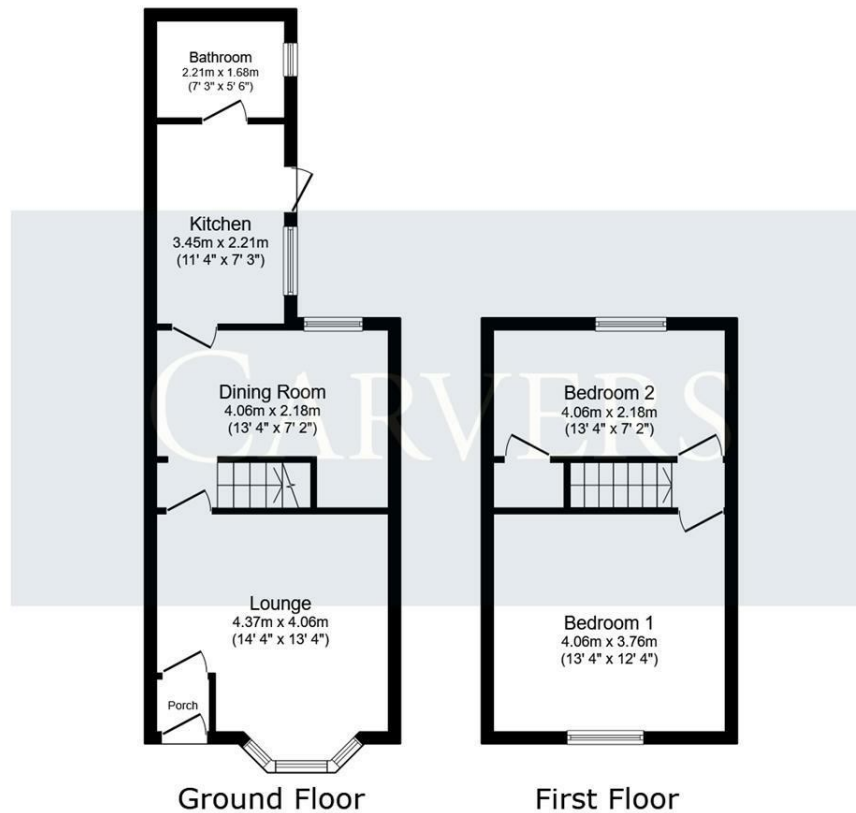
Buyers Identification Checks
