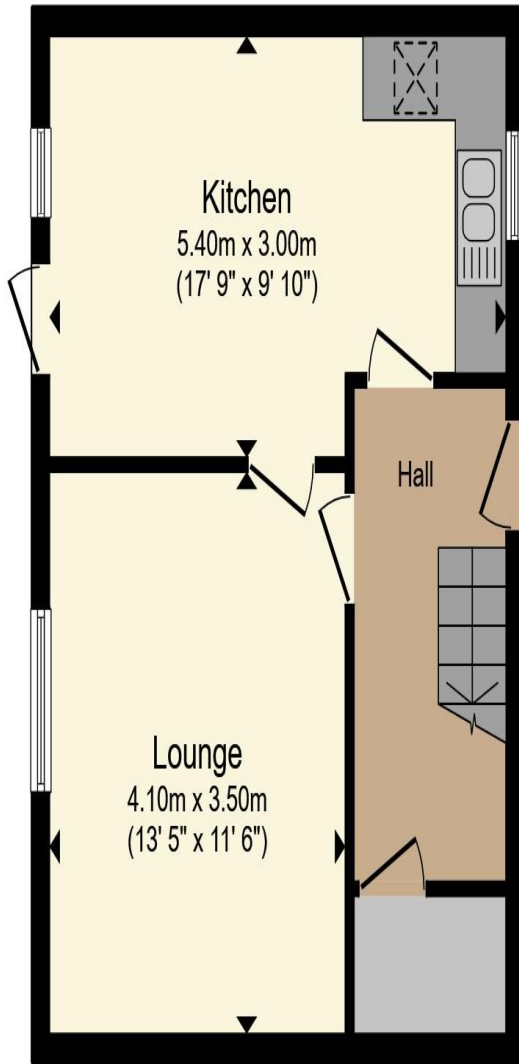

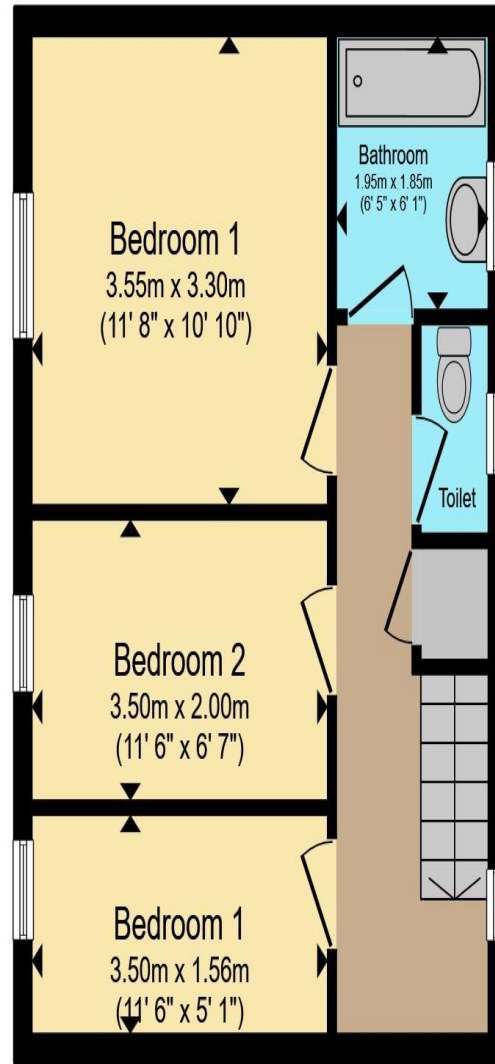
into Central London in 50 mins.
