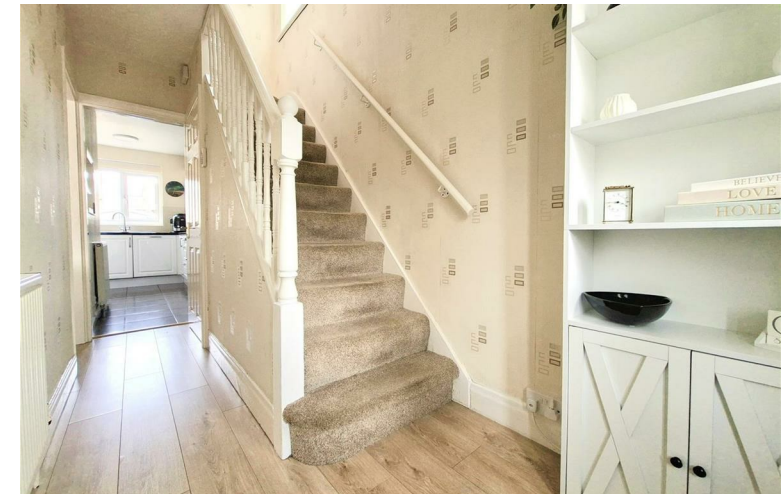
A well presented, extended semi detached house on a popular road in Yardley.

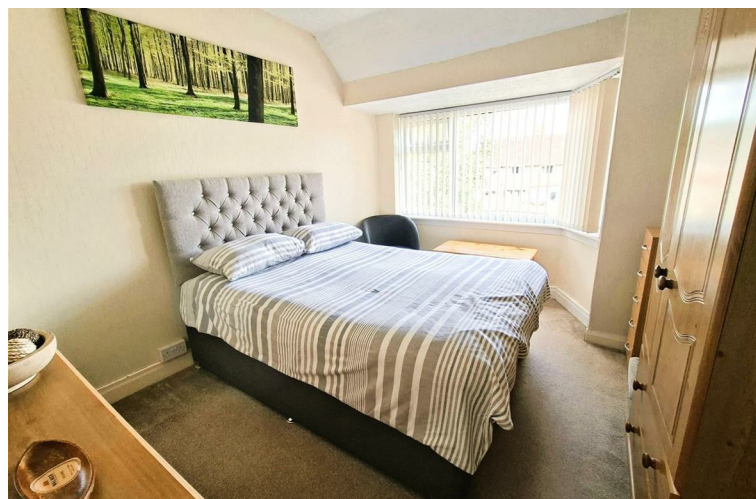

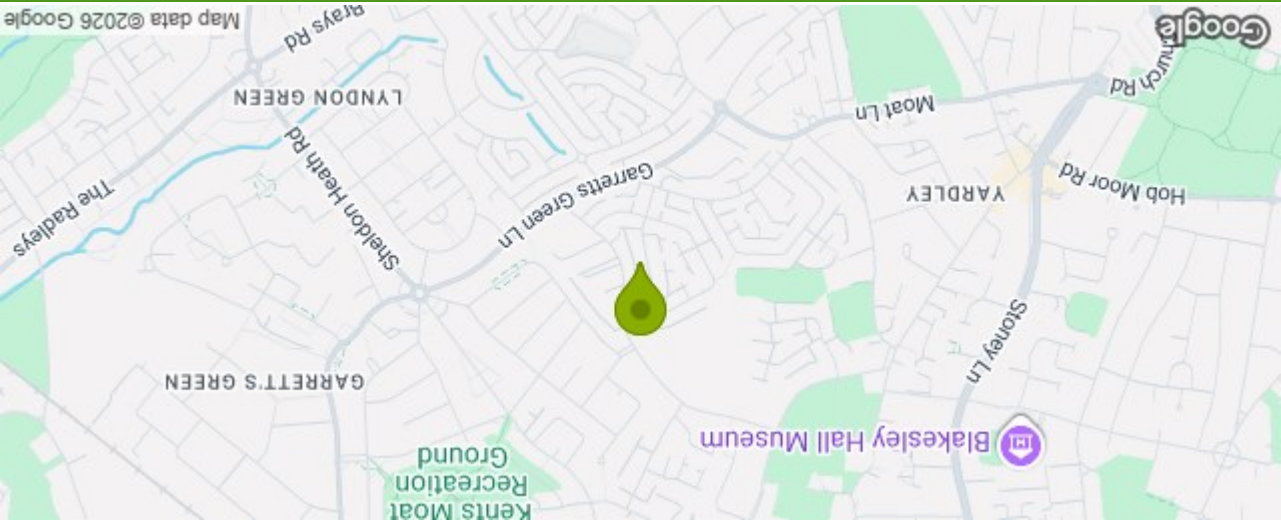

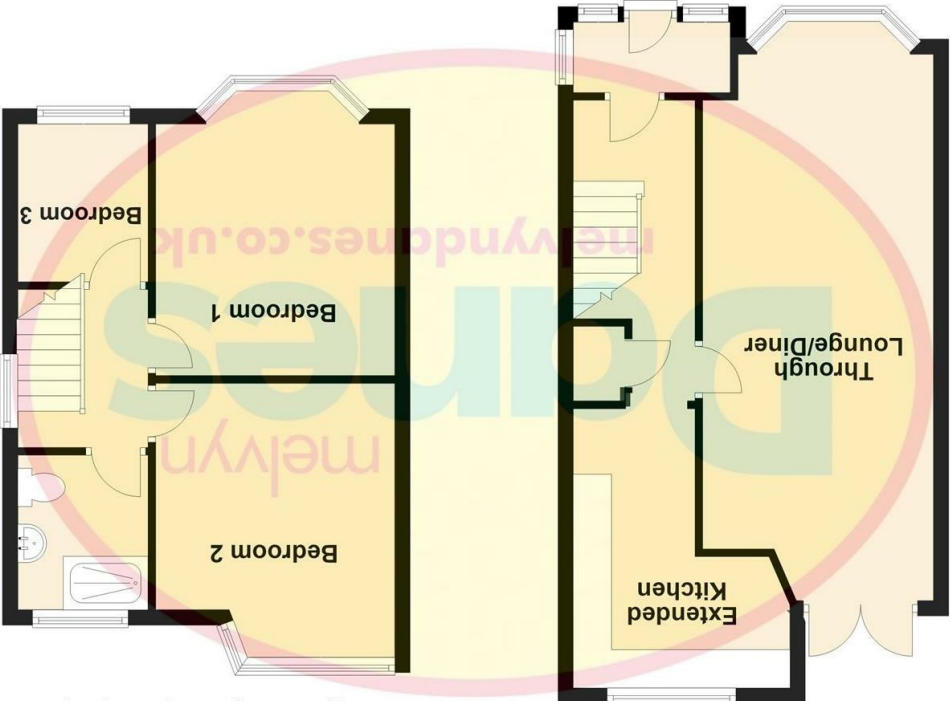
