



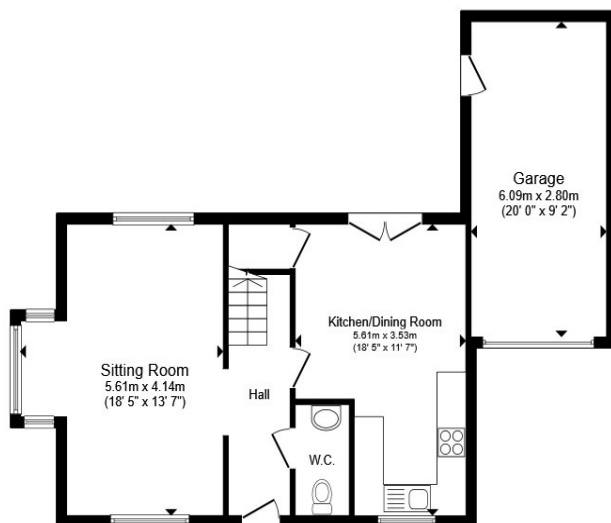

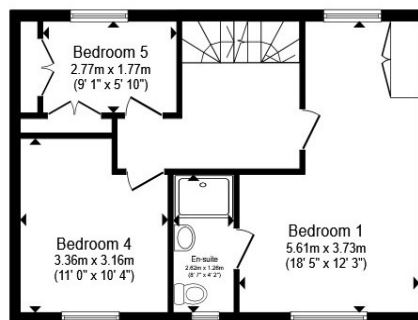

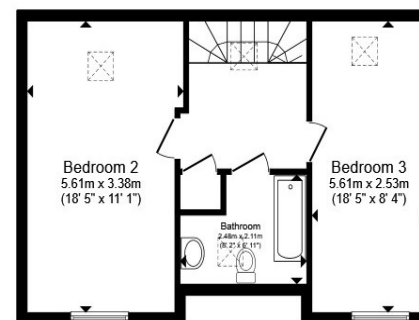




Ground Floor

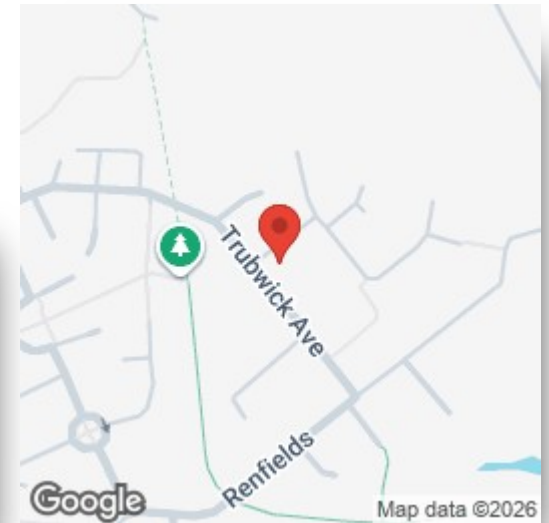
