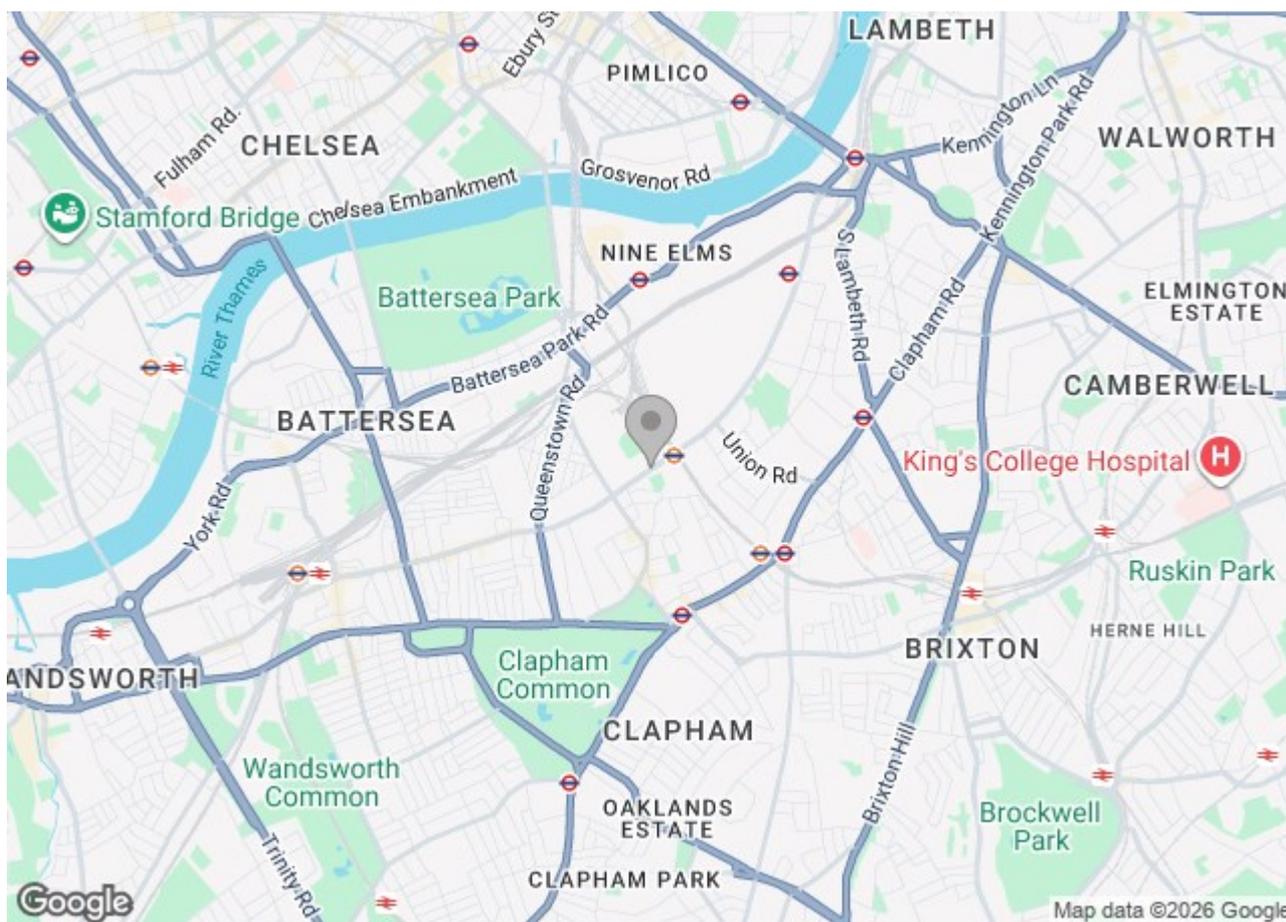

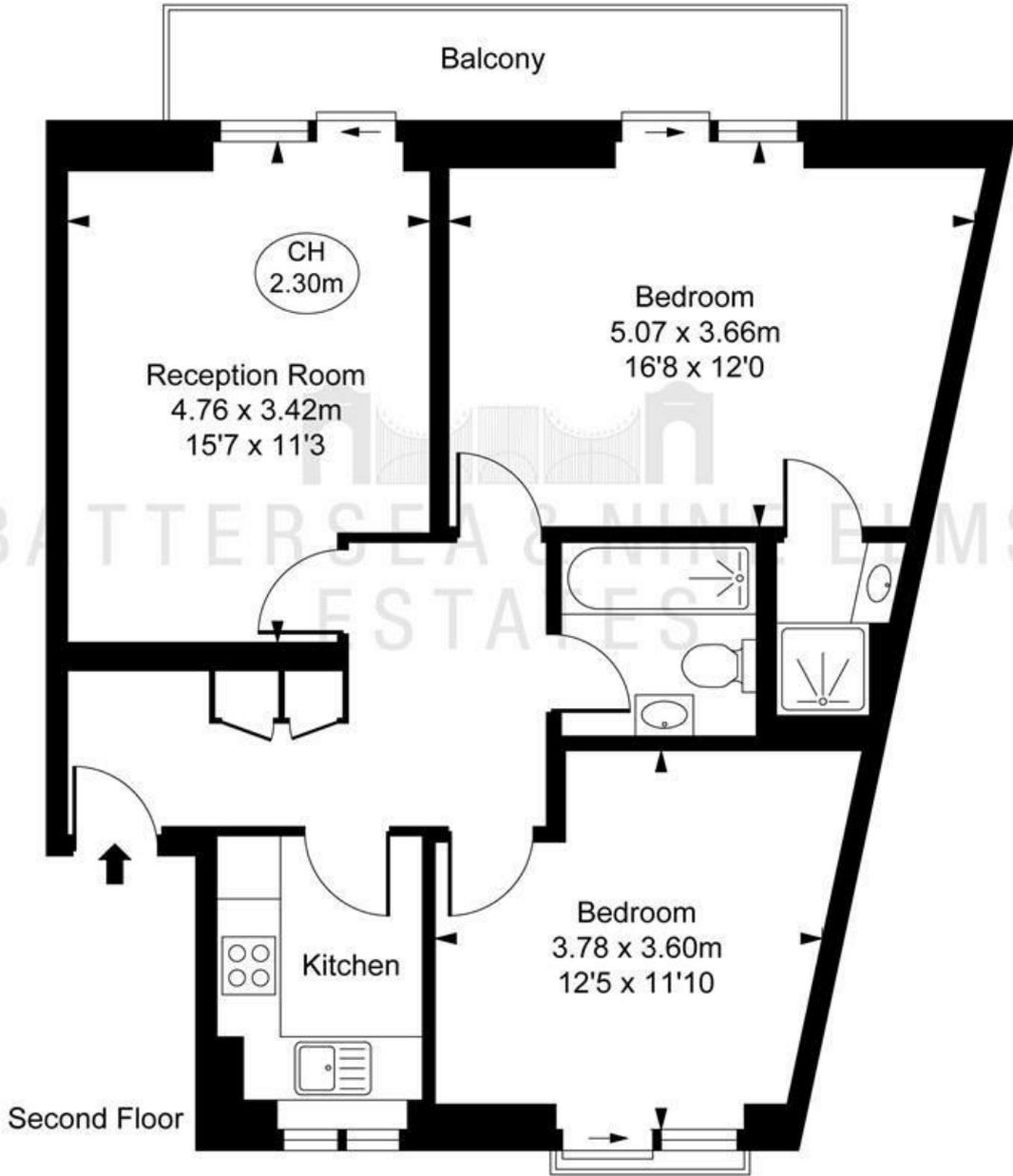
Floor Plan
