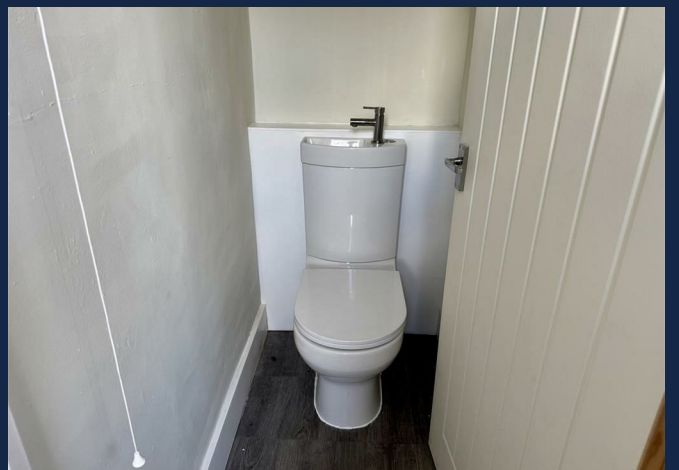

Approach

Via a slabbed driveway with stone chippings, open porch and double glazed front door leading into the entrance hall.

Entrance hall

Stairs to first floor accommodation, central heating radiator, doors into kitchen, two reception rooms, under stairs storage cupboard.

Double glazed bay window to front, central heating radiator, feature fireplace surround.

Double glazed obscured window to rear, pedestal wash hand basin with mixer tap, low level flush w.c., bath, central heating radiator.
