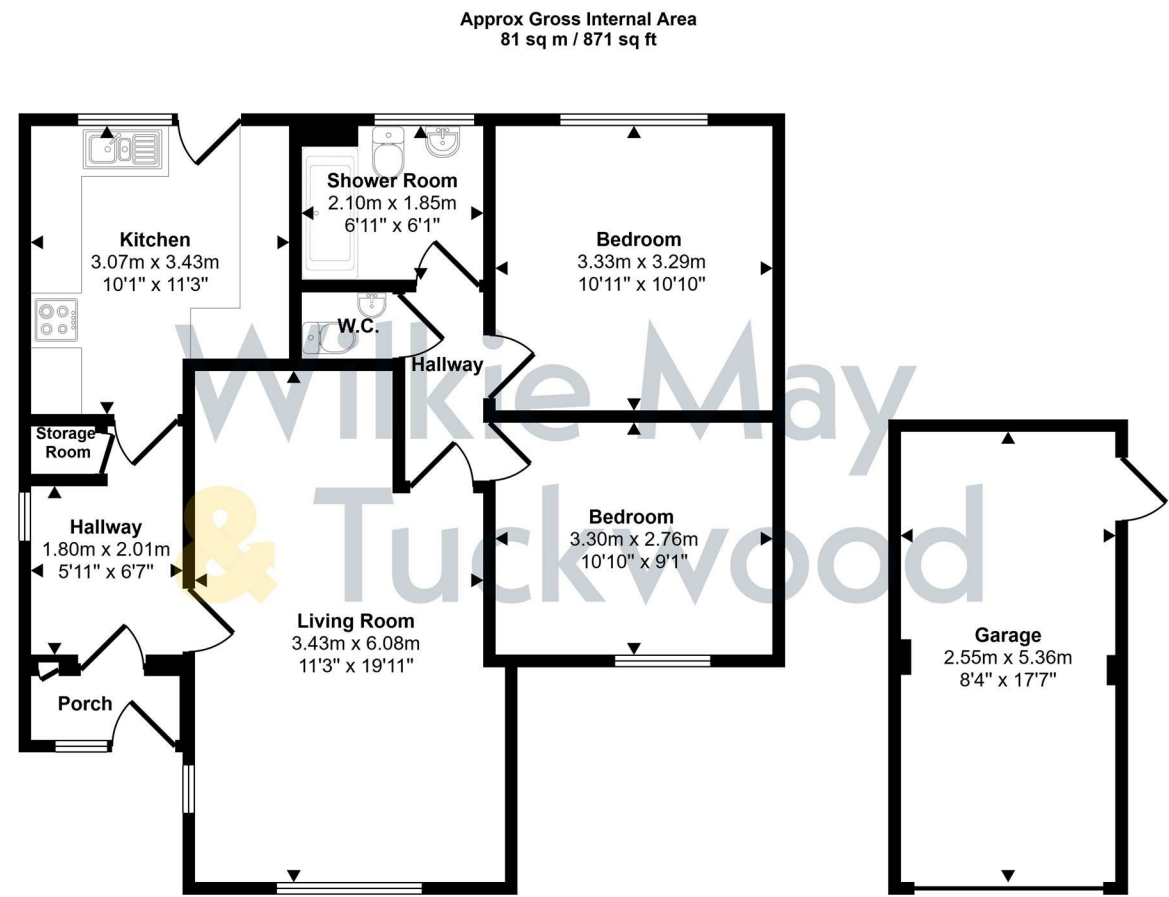

The accommodation in brief comprises; Obscure Glazed door into Entrance Porch; glazed door into Entrance Hall; storage cupboard. Living Room; with double aspect. Kitchen; with aspect to rear with far reaching sea views, tiled floor, fitted kitchen comprising a good range of cream coloured cupboards and drawers under a wood effect laminate rolled edge worktop with inset ceramic one and a half bowl sink and drainer, mixer tap over, space and plumbing for washing machine, space for electric cooker with extractor hood over, tiled splashback, space for under counter fridge. Rear Hall; hatch to roof space with ladder and combi boiler for central heating and hot water. Bedroom 1: aspect to rear. Bedroom Two; aspect to front. Separate Wc; tiled floor, low level WC, wash basin. Shower Room; with tiled floor, shower cubicle with tiled walls, thermostatic mixer shower over, low level WC, pedestal wash basin, heated towel rail.
