

Sanford Rise is a stunning three bedroom semi-detached family home, set in a pleasant plot position on a quiet road within the popular Jurston Fields development, built by reputable family builder C G Fry & Son in 2021. The property benefits from the remainder of its 10 year builders' warranty, offered to the market with **NO ONWARD CHAIN**.

The property was fitted with a number of extras, including quality worktops, induction hob, hard flooring throughout and fitted wardrobes in the main bedroom. An internal viewing comes highly recommended to fully appreciate the quality and finish of this home.

The accommodation is arranged over two floors and briefly comprises; front door opens into the entrance hallway with a cloakroom, stairs rising to the first floor and doors to the principal rooms. The sitting room has a window to the front elevation and a feature fireplace along with French doors to the rear garden. There is a large open plan kitchen/dining room offering two distinct areas including a generous dining space whilst the kitchen itself is fitted with a comprehensive range of wall and base units and tiled splashbacks with a full range of integrated appliances. The adjoining utility room offers further space for appliances along with access to the rear garden.

To the first floor there are three bedrooms with the master benefiting from an en-suite shower room whilst the family bathroom is fitted with a three-piece white suite with a shower over the bath. The back bedrooms have views over the town and also to Wellington Monument.

Outside, the property is approached via a step and to the side there is a driveway/parking for two cars, in turn leading to the garage which is fitted with an electric up and over door. The rear garden is predominantly laid to lawn with west facing views from the patio area and enjoys a good degree of privacy.
