Entrance Hall

Kitchen

Comprising of a fitted kitchen with a range of both wall and base units with complimentary work surfaces over. Includes a one and a half bowl sink and drainer, an electric hob with a splash back and a cooker hood unit over. Also has two double glazed windows to the front aspect.

With stairs rising from the ground floor and having a double glazed window to the front.

Double glazed window to the rear and a gas central heating radiator.

Bedroom Two

Double glazed window to the front aspect and a gas central heating radiator.

Shower Room

Fitted with a shower cubicle, wash hand basin and the w.c. Tiled flooring, part tiled walls, heated towel rail and a double glazed window to the front aspect.

Exterior

Externally the property has a driveway to the front while to the rear is a garden space which is mostly laid to lawn and includes a patio seating area, and a gravel area with a pathway to the outbuilding.

Equipped with plumbing and electrics with a door and window to the front.


