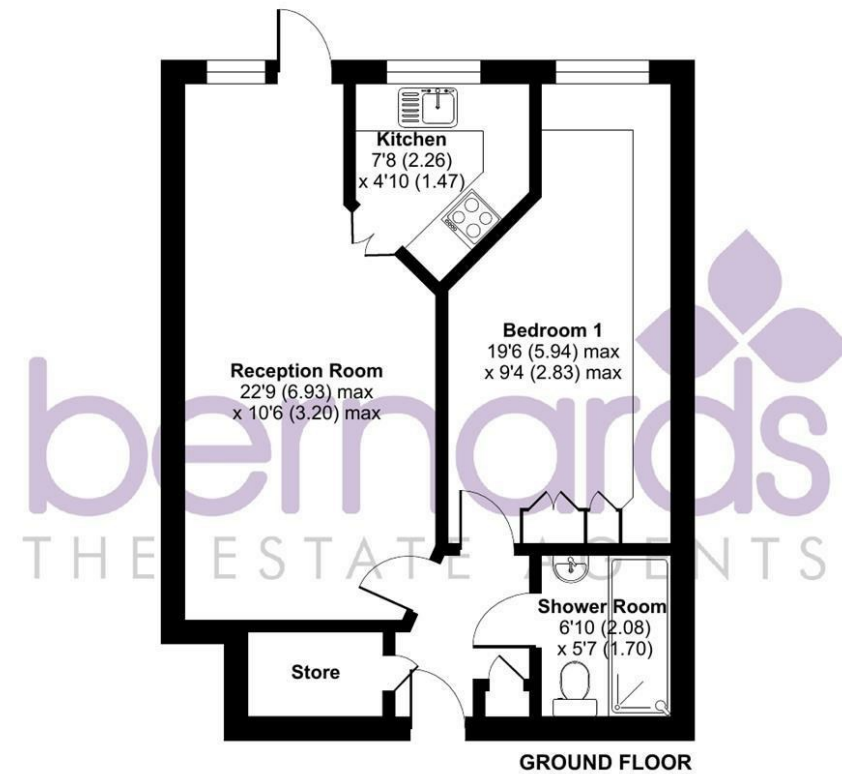




Marine Parade East, Lee-on-the-Solent, PO13
