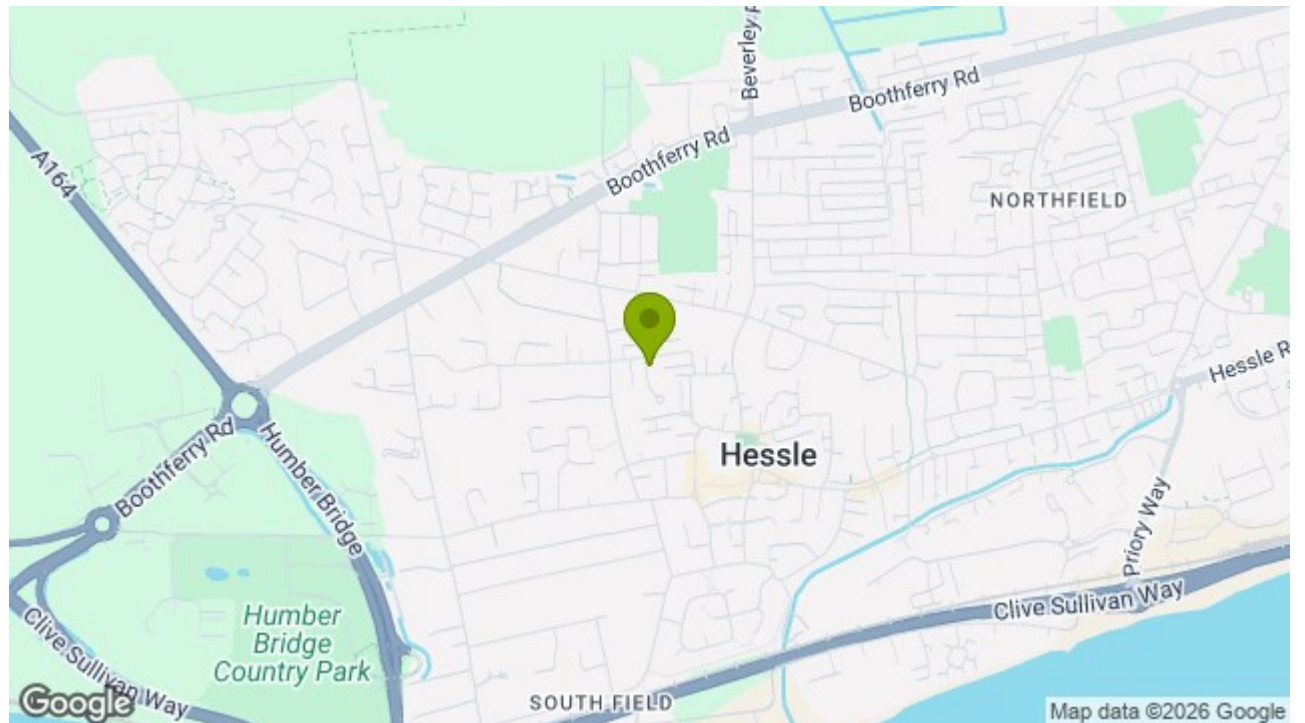

## HESSLE

The Town of Hessle is well served for local amenities with first class shopping facilities available within the Town Centre, public transportation & local primary and secondary schools. Good road and rail connections are available with a local train station off Southfield, and the A63 dual carriageway running nearby to the South of the town, allowing convenient access to Hull City Centre and the national motorway network.

## GROUND FLOOR;

### ENTRANCE HALL

Providing access to the accommodation with stairs off.

### LIVING ROOM

A beautifully presented living space with a bay window to the front elevation and a feature fireplace housing a log burning stove.

### DINING KITCHEN

Superb dining kitchen with blue shaker wall and base units, laminated work surfaces and a tiled splashback. Integrated appliances include an Electric Hob, Electric Oven, Extractor Fan, Dishwasher and a Sink Unit. Further benefitting from windows to the side and rear elevation, storage cupboard and ample dining space.

### UTILITY ROOM

A handy space with plumbing for an automatic washing machine and space for a tumble dryer, door leading to the rear garden and providing access to the WC.

With a low flush EC, wash hand basin and a window to the rear elevation.

A bedroom of double proportions with two windows to the front elevation.

### BEDROOM 2

A further double bedroom with storage cupboard and a window to the rear elevation.

### BATHROOM

A four piece suite comprising of a free standing bath, a shower enclosure, a wash hand basin and a WC. Further benefitting from partially tiled walls, a heated towel rail and a window to the rear elevation.

## EXTERNAL;

Benefitting from a sizeable front garden with timber fenced and gate, herbaceous borders and a garden shed.

### REAR

Landscaped rear garden with paved patio and footpath, raised decking area, artificially turfed lawn and a storage shed.
