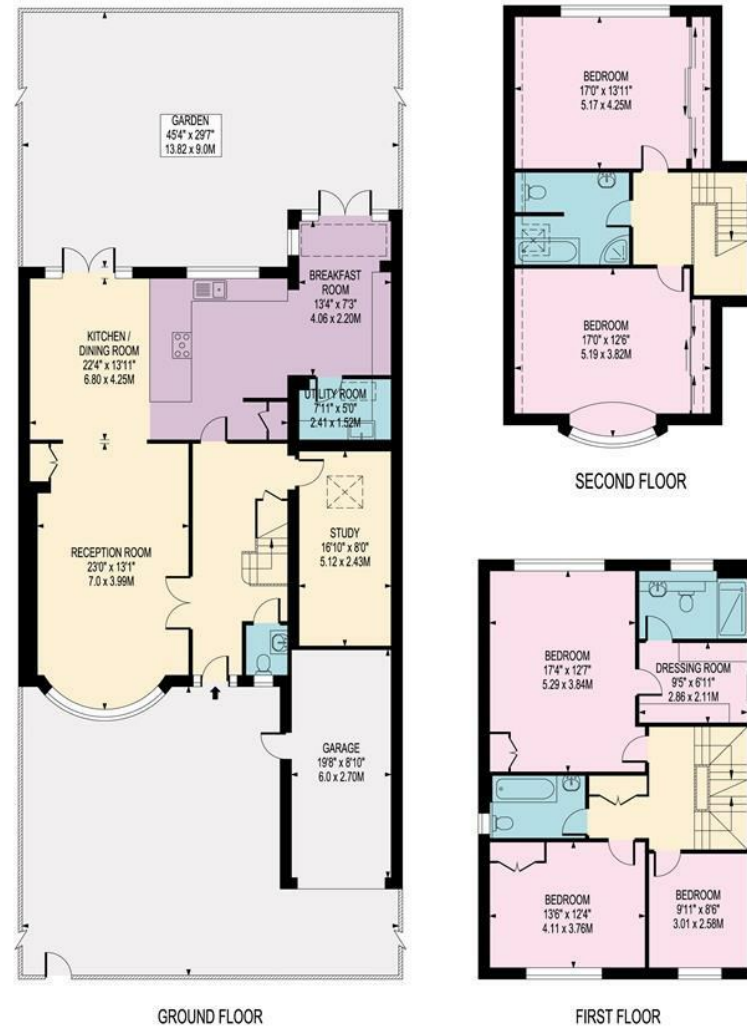


COTTENHAM PARK ROAD

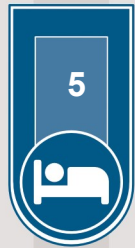

THE LOCATION

Positioned at the top of Cottenham Park Road, just off Ridgway this is a convenient location for the Village High Street, the Common and Raynes Park. The town with its excellent mainline and District Line tube stations is within walking distance. THE PROPERTY
