A wonderful renovated house close to the beach



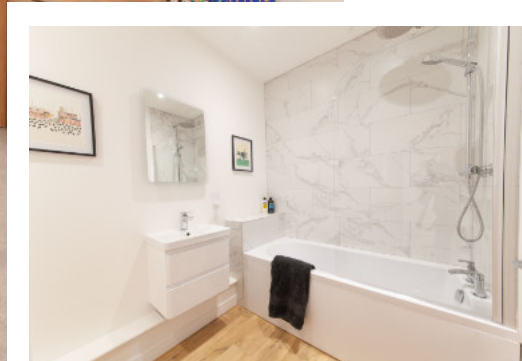
Wells Park House is a deceptively spacious and highly versatile four-bedroom home, ideally situated in the sought-after coastal village of Stoke Fleming.

Comprehensively renovated in 2023, the property offers exceptionally light and well-proportioned accommodation arranged over three floors. A particular feature is the flexibility of the layout, including a principal ground floor bedroom suite, making it well suited to multi-generational living or those seeking single-level convenience.

Accommodation

The ground floor comprises a generous entrance hall with stairs rising to the upper levels, a cloakroom with WC and wash hand basin, and a well-equipped utility room with plumbing for a washing machine and tumble dryer, along with a hot water cylinder and air source heating system.

To the front is a spacious principal double bedroom with an en-suite shower room. To the rear, a guest double bedroom overlooks the courtyard garden and benefits from an en-suite bathroom with shower over. A useful office/store room provides additional flexibility and offers direct access to the sunny rear courtyard.



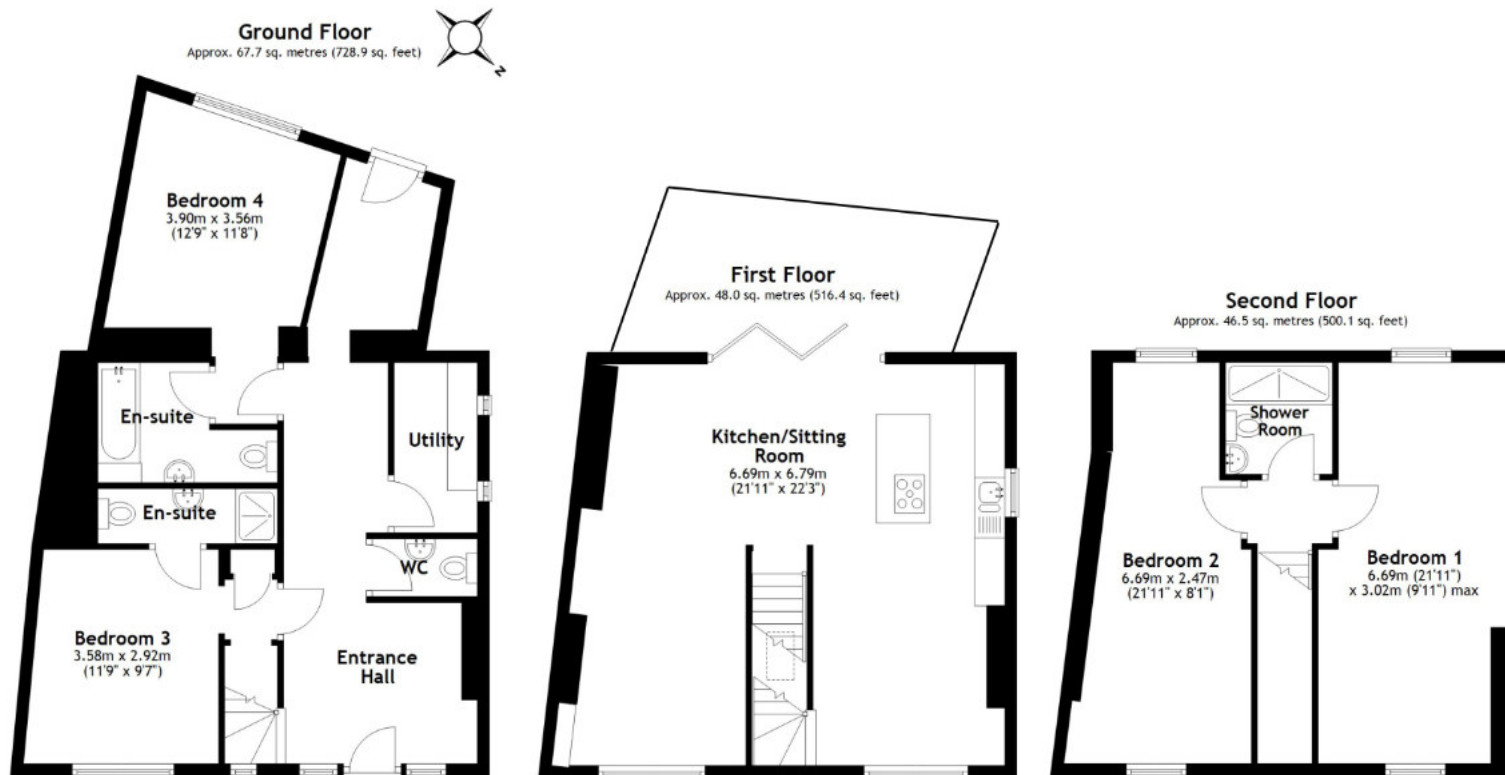


The first floor is a standout feature of the home, with a stunning open-plan living, dining and kitchen space designed for modern living. The contemporary kitchen is fitted with a comprehensive range of units and integrated appliances, including double oven, fridge/freezer, dishwasher, induction hob with extractor, and a central island with ample work surfaces and a one-and-a-half bowl sink.

The adjoining living area enjoys a front aspect window and large bi-folding doors opening onto the courtyard, creating a seamless connection between indoor and outdoor spaces. The dining area also benefits from a front-facing window with attractive glimpses towards Start Bay.

On the second floor are two further double bedrooms, both enjoying dual aspects with views across the village and towards the coast. A stylish shower room with large walk-in shower, WC and wash hand basin serves this level.

Externally, the property offers a gravelled parking area to the front for one vehicle, with steps leading to the entrance. To the rear is a generously sized, enclosed courtyard garden with pedestrian access to the front, along with outside tap and power.

Additional benefits include uPVC double glazing and an energy-efficient air source heating system.
