## Description

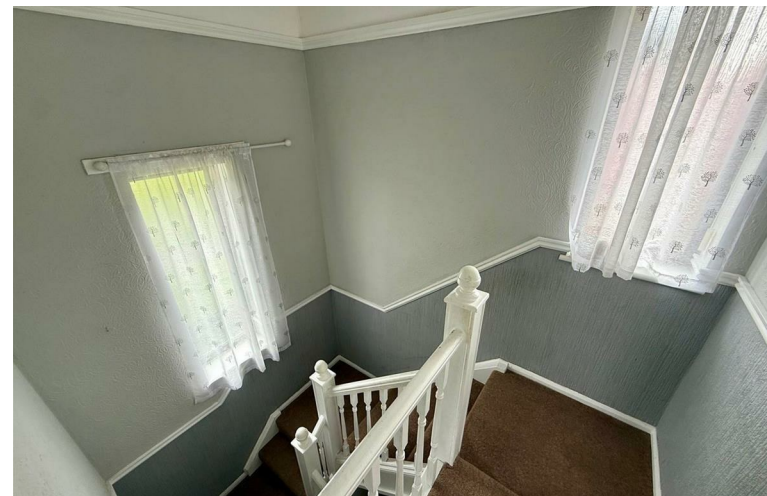
Headley Rise is ideally located off Blenheim Road which is great for the amenities of Shirley, situated between Longmore Road which leads directly from the Stratford Road and Yoxall Road which links up to Danford Lane.

We are advised that the property is situated within the catchment area of Tudor Grange School with infant schooling being at Blossomfield Infant School which leads from Lawnswood Avenue, and junior schooling at Shirley Heath School which leads from nearby Union Road. Also nearby, on the main Stratford Road, is Our Lady of the Wayside Roman Catholic Junior and Infant School. All education facilities are subject to confirmation from the Education Department.

The main shopping centre in Shirley offers a wide choice of Supermarkets, convenience and speciality stores, restaurants and hostelrys and there are frequent bus services running along the A34 into Birmingham City Centre and Solihull Town Centre – boasting the vibrant and modern Touchwood Centre offering shopping facilities and evening entertainments. Shirley and Solihull have their own railway stations providing a train service to Birmingham City Centre and London from Solihull.

Off the main Stratford Road leads Marshall Lake Road boasting the Retail Park and further down the A34 one will find the Cranmore, Widney, Monkspath and Solihull Business Parks, and on to Blythe Valley Business Park which can be found at the junction with the M42 motorway, providing access to the Midland Motorway Network. A short drive down the M42 to Junction Six, you will find Birmingham International Airport and Rail Station.

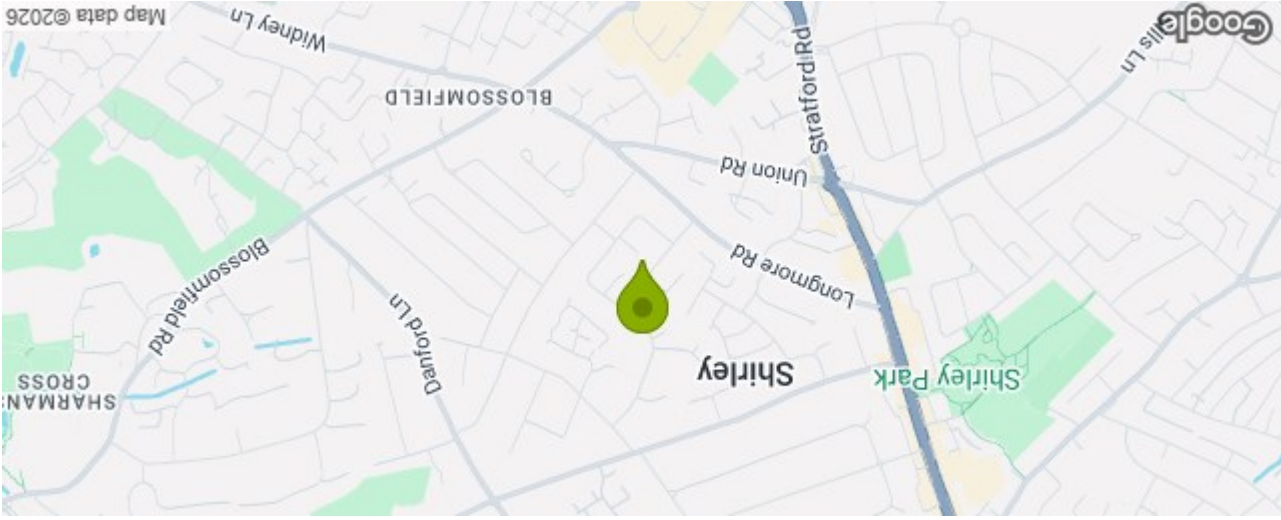
