



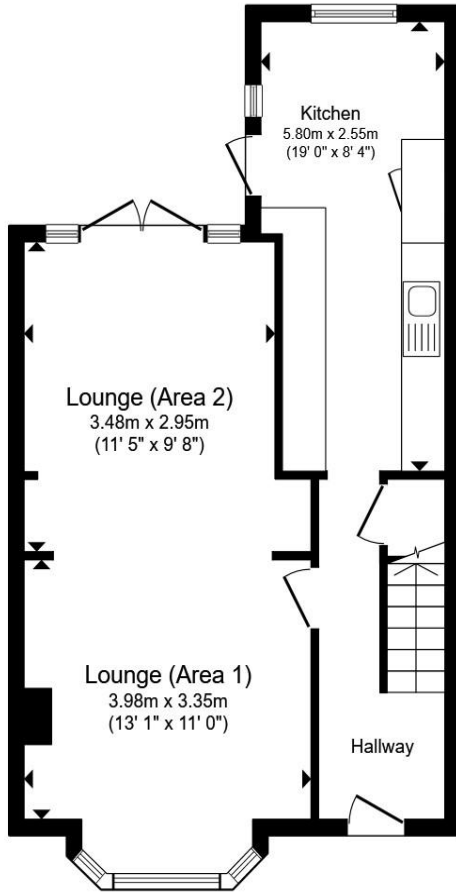

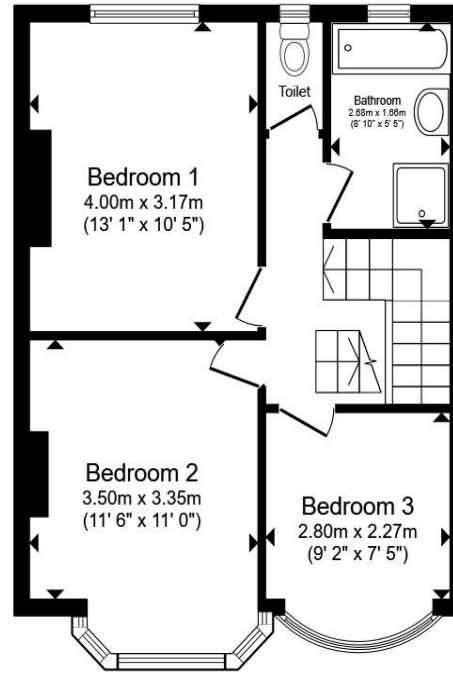

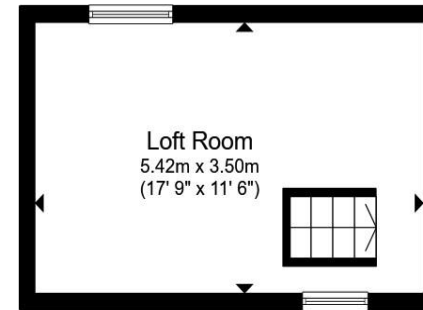




Ground Floor
