The property benefits from private rear garden and double glazing and comprises one double bedroom with fitted wardrobe, living room, bathroom and kitchen.

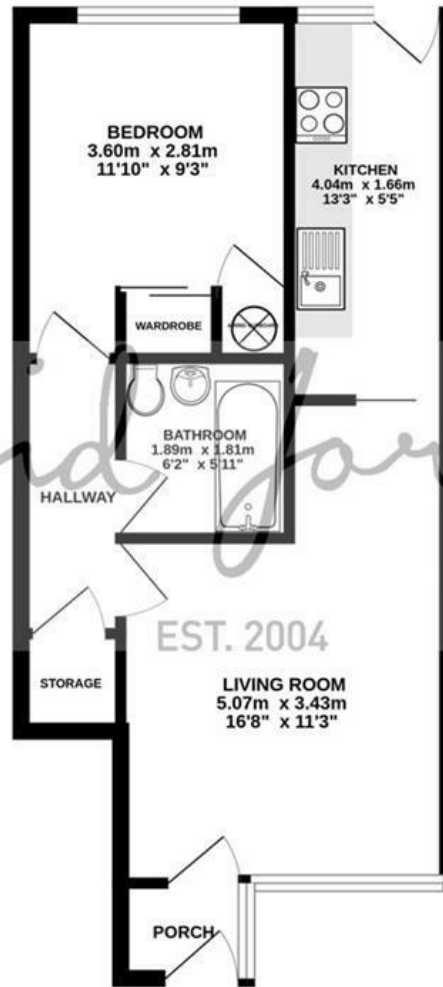

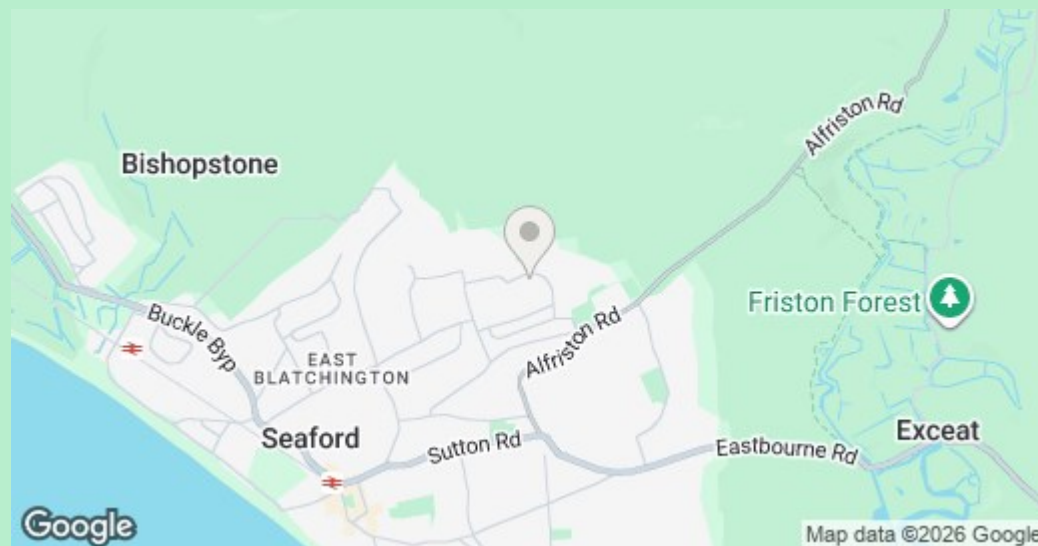
