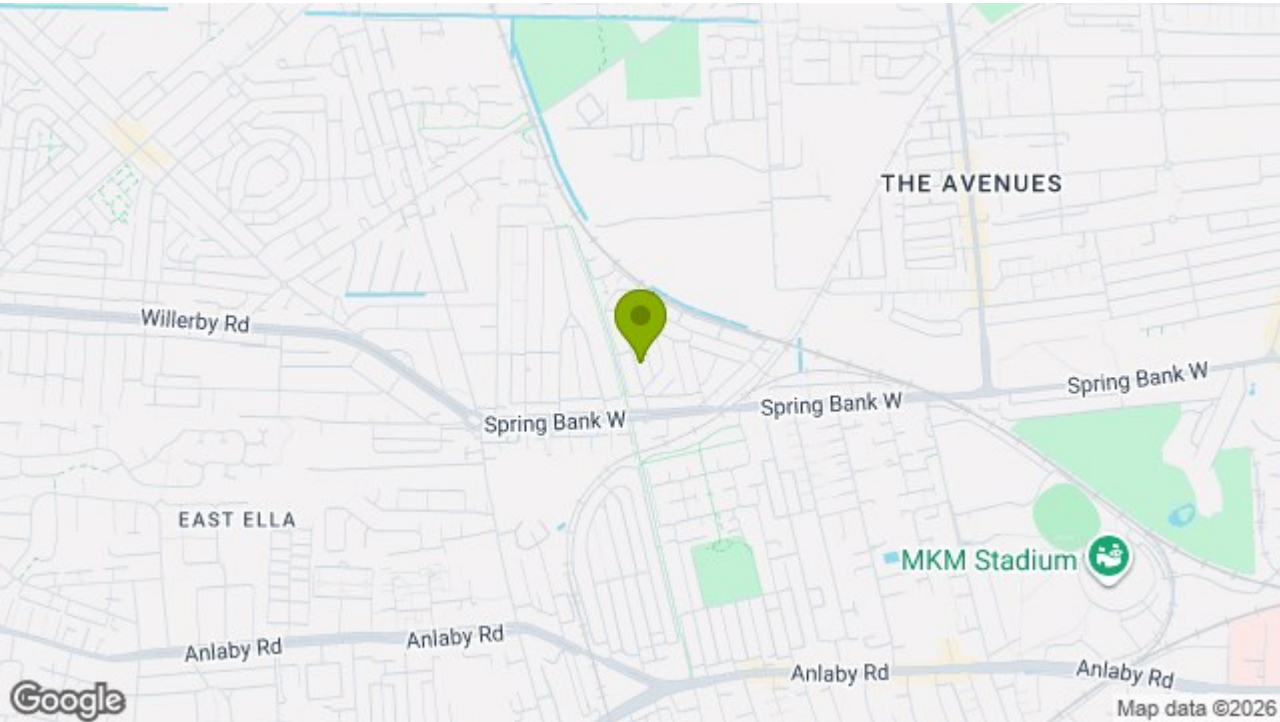

ENTRANCE HALL

Providing access to the accommodation with stairs off.
