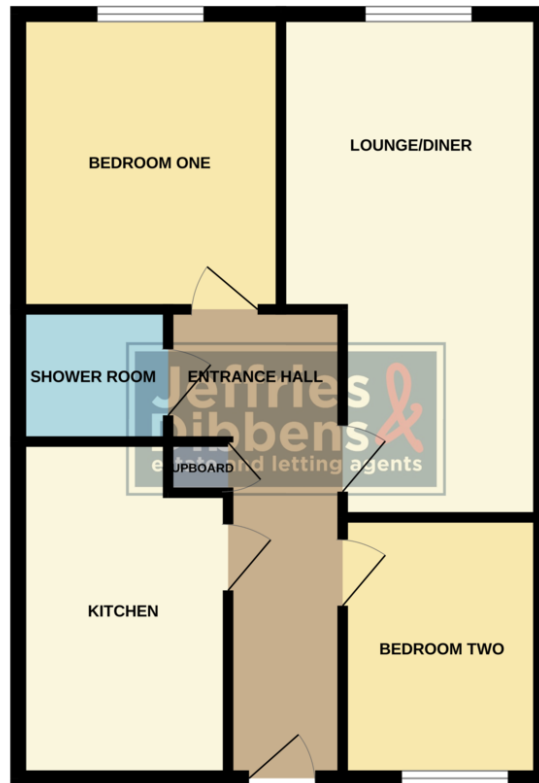

2ND FLOOR APARTMENT



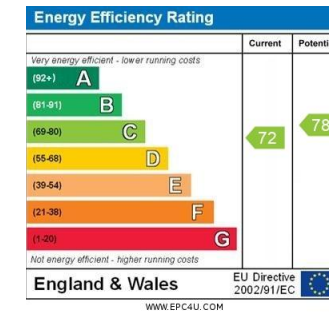
